
Show Us the Science

I am holding a protest titled **Show Us the Science** on Parliament Hill (File number: 2021-177) from October 4 to October 18. This is a one-man protest against the fraudulent emergency health measures. I am making two demands of the federal government, both of which are extremely reasonable and can be readily fulfilled should the government choose to do so. If either demand is fulfilled then I will immediately terminate my protest and leave Parliament Hill. In short, my first demand is that the federal government produce its records that prove the alleged virus Sars-Cov-2 and the alleged disease Covid-19 are real and actually exist. Alternatively, my second demand is for the federal government to acknowledge it has no proof that the alleged virus and alleged disease exist. I will only have enough food and water for the first week of my protest. If the federal government ignores my demands then I will not survive the second week of my protest and will die.

Context of my protest

Our rights and liberties are violated daily under fraudulent Covid-19 emergency health measures, measures that are not based on true science. I refer to this as the Covid Fraud and it has nothing to do with protecting public health and safety. The Covid Fraud is a globally engineered crisis based on the fictitious virus Sars-Cov-2, the fictitious variants and the fictitious disease Covid-19. The purpose of the Covid Fraud is to coerce the public into accepting Technocracy and Transhumanism, also referred to as One World Government, the New World Order, the Great Reset and the Fourth Industrial Revolution.

There is no open/public debate/discussion on the Covid Fraud. Public discussion has been shut down and censored at all levels of government and industry. There is widespread and omnipresent censorship on major social media platforms against all data and information that challenges and refutes the fraudulent official covid narrative. Official covid propaganda is spewed 24/7 on all mainstream media. Government and industry extortion is rampant as professionals and non-professionals around the world are threatened with the loss of their livelihoods and even their lives for challenging, refuting and exposing the Covid Fraud.

I will never consent to any of the dangerous experimental injections that are euphemistically referred to as '*vaccines*' or '*gene therapy*'. There is no science that proves these experimental injections provide any health benefits. These dangerous injections have not passed or been subjected to any of the standard medical safety protocols and regulations. Clinical trials will not even be completed before 2023. These dangerous injections have only been authorized for use under Interim Orders, that is, emergency authorization. The FDA may have just authorized the Pfizer injection but the reality of regulatory capture completely invalidates this authorization. Government and industry are using extortion, threatening loss of job and livelihood, to force Canadians into getting these injections. Extortion is a crime under section 346 of the Criminal Code of Canada.

Experts and other highly qualified professionals from around the world are reporting on the dangers of these experimental injections. Even by official numbers, the number of deaths and serious injuries from these injections are far higher than from all other '*vaccines*' in the past 30 years. We know with

absolute certainly that these official numbers grossly underestimate the real number of deaths and injuries.

These dangerous injections are euphemistically referred to as ‘*vaccines*’ and ‘*gene therapy*’ when in reality what they constitute is uninformed and nonconsensual genetic experimentation on humans. These dangerous injections are only referred to as ‘*vaccines*’ so as to exempt pharmaceutical companies, to give them full immunity, from legal liabilities that would otherwise bankrupt them and punish them for crimes against humanity. They are referred to as ‘*gene therapy*’ to deceive the public into believing they serve beneficial medical purposes; this is false.

We originally heard from the likes of Bill Gates that we would need only one injection for lifetime protection. Within 8 months, Gates was saying it would be two injections. Quoting from the Government of Canada’s web site today, “*The Government of Canada has committed over \$9 billion to procure vaccines and therapeutics... A majority of that amount has been allocated for the up to 409 million doses of vaccines and vaccine candidates secured for everyone in Canada.*” (see *Procuring vaccines for COVID-19*: <https://www.canada.ca/en/public-services-procurement/services/procuring-vaccines-covid19.html>). With a population of 38 million people and factoring in potential spoilage/wastage, this still amounts to many injections for every Canadian. How did we get from one injection for lifetime protection to multiple injections and boosters every year moving forward? The answer is that there is another agenda at play and that agenda has nothing to do with protecting public health and safety. You, our leading politicians and health authorities, are willfully complicit in serving this agenda, feeding us misleading and false statements that these dangerous injections are safe. You are liars and are lying to us!

I do not consent to wearing a mask. There is little to no science that masks protect against the alleged virus Sars-Cov-2. Since July of 2020, I have been denied access to all private and public services because I refuse to wear a mask. I have not been able to see my doctor or dentist. I cannot go into grocery stores and supermarkets to buy food and clean water. I cannot go into stores to buy essentials or non-essentials. I am denied access to all public transportation. I have no reliable source of clean drinking water outside my home. I cannot use and have been denied access to public washrooms. I am completely dependent on family members for survival. I do not have a segregation document euphemistically referred to as a “*vaccine passport*”. As of September 1 in Quebec, I am denied access to all restaurants, gyms and sporting events. Hospitals in Ottawa have announced visitors must show their segregation document to get into the hospitals. If you do not have a segregation document then you cannot accompany or visit your loved ones in the hospital, including your children. These are insidious restrictions; the walls are slowly closing in on us. I am effectively discriminated against and segregated in and by my own country for standing firm in my beliefs, convictions and what I hold to be true and right.

Refusing to wear a mask is not an option. If you do not have family members to depend upon then refusing to wear a mask is a death sentence; no mask, no food. Comply or die! This policy is reinforced by the segregation document with there already being instances in France where people without the segregation document are being denied access to supermarkets. Let us call this for what it is. This is extortion by government and industry and it is criminal.

This is the Canada that our prime minister and all premiers have created. You, our leading politicians and health authorities, have failed the people you are supposed to serve and protect. With the Covid

Fraud, you have demonstrated where your loyalties lie. You serve the interests of the elite criminals, those euphemistically referred to as the global elite. You do not serve the interests of Canada and the Canadian people, this being particularly true of Theresa Tam whose conflict of interest with the privately controlled World Health Organization and Chrystia Freeland whose conflicts of interest with the privately controlled World Economic Forum render them unfit to hold public office. You have betrayed all Canadians and, in doing so, you are traitors to Canada and the Canadian people.

I am publicly stating that our governments have no credible scientific data to support any of the emergency health measures. With my protest, I am calling their bluff.

Terms of my protest

I refuse to wear a mask and get the dangerous experimental injections. This means that I will not be able to buy food and water in Ottawa. I will not be allowed to rent a hotel room to take shelter at night.

There is a high price to pay for not complying with the fraudulent emergency health measures and that price is death. No mask, no food. Therefore, there must be a high price the government will pay if it ignores my demands; that price will be my life.

I will leave Montreal on October 4 and arrive in Ottawa to start my protest between 12:00 and 15:00 hrs. I will bring enough food for the first few days of my protest and enough water for the first week of my protest. I will be without food and water for the second week of my protest. I will not accept food or water that any might offer to me. I will be forced to sleep on the streets of Ottawa. Fall is here and the temperatures at night are getting colder. My demands on the government are simple and it can quickly fulfill them should it choose to do so. But if the government ignores my demands then I will die. My protest is not a hunger strike. I want to eat, I want to drink, I want to live.

The government may not care if I die. But millions of Canadians will be outraged if the government allows one of its citizens to die simply because he demanded to know and understand the science the government claims it is basing the emergency health measures on. In these dire times, my demands go well beyond reasonable and are of interest to every Canadian and indeed, every citizen of the world.

The federal government has two choices. The first choice is it can show I am wrong and provide the records that prove its emergency health measures are based on true science. The second choice is it acknowledges it has no records, that it is not basing emergency health measures on true science.

The price the government will pay for refusing to meet my demands will be my life. I am drawing my line in the sand. This is a hill worth dying on, figuratively and literally.

Here are my two demands for the federal government.

Demand #1

The government alleges there have been four waves of the virus and its variants. Starting with March of 2020 and for each of the four waves, I am demanding the government produce and clearly identify the following:

- a) All records, if any, that prove the alleged virus has been purified/isolated as specified by the Statement on Virus Isolation (SOVI) <https://andrewkaufmanmd.com/sovi/>).
- b) All records, if any, that prove the alleged virus has been purified/isolated by means other than specified in the Statement on Virus Isolation.
- c) All records other than those from points *a* and *b*, if any, that prove the alleged virus/variants are real, that they exist.
- d) All records which prove the alleged virus or alleged variants cause the alleged disease Covid-19.

All records must be clearly identified/classified according to the above four points so that there is no guessing or speculation on my part or any other Canadian. The intention here is to know/understand exactly what records the government has that prove the alleged virus, its alleged variants and the alleged disease exist and are real. Note, I am not asking for any records that *assume* or *claim* the alleged virus, variants and disease have already been proven to exist. *Do not include any records which assume/claim the alleged virus/variants/disease have been proven to exist.*

The government need only provide a full citation to a scientific paper if that paper is published in a recognized and respected scientific journal. Otherwise, I am demanding the government make available the entire contents of the scientific paper.

All records must be made available in electronic format and accessible for download by the public for at least one year. Instructions on how to access and download these records must be prominently displayed on the federal government's main coronavirus web page (see <https://www.canada.ca/en/public-health/services/diseases/coronavirus-disease-covid-19.html>). A copy of these instructions must also be given to me so that I can have someone download and quickly review all records before I terminate my protest.

Demand #2

Alternatively, I will end my protest if:

- a) The government publicly acknowledges, in a written statement, that it has no records that prove Sars-Cov-2 is real, as specified in points *a*, *b* and *c* of Demand #1;
- b) The government explain in this written statement what basis it is using to justify the emergency health measures (e.g. directives received the World Health Organization);
- c) This statement is signed and dated by an authorized government official;
- d) This statement is also signed by the prime minister or a person officially acting on his behalf.

The intention here is simple; for the government to publicly acknowledge it has no records that prove the existence of the alleged virus Sars-Cov-2 and, by consequence, the existence of the alleged disease Covid-19.

My Last Wishes

If our leading politicians and health officials are acting in the interest of Canadians then the records I am demanding will be made publicly accessible without delay. However, they are only acting in the interests of the elite criminals and, for this reason, the federal government can be expected to ignore or use some legalese to ignore my demands, demands that shine the spotlight on corruption and treason at the highest level of government. If my demands are ignored then there is only one way forward.

At home, if I am injured or sick, I cannot go to my doctor or get medical services/treatment because I refuse to wear a mask. Therefore, when I lose consciousness during my protest, I do not consent to any medical services or treatment. If I regain consciousness then I will resume my protest. If I do not regain consciousness then I am not to be revived, even if my death is imminent. Under no circumstances am I to be taken to a hospital or any health-care facility. What is denied to me in life when I was in good health will be denied to me unto death. If there is anyone who can see that my wishes are respected, make certain medical services or treatments, and especially the dangerous experimental injections, are not forced on me when I am no longer able to fight for myself.

This is my fight against the Covid Fraud. This is my line in the sand and I expect to fall. But when I do, in one form or another, there will be another to carry on the fight, and another after that, and another after that. We are fighting for our constitutional rights, our civil liberties, our freedom and a way of life that we choose! These are our inalienable rights and no one - not government, not industry and most of all, not the elite criminals - can take them away from us. We are being called upon to make the same sacrifices previous generations made for us. Many of us will fall but we will not waver in our fight for what we know to be true and right!
