

# Winning this war – Part 1

## Introduction

A global war of Technocracy and Transhumanism (T&T) is being waged against us, the little people. This is World War III. There is only one way for us to win this war. We are not doing it.

This is a proposal for winning this war<sup>1</sup>. It requires we drastically change our strategy, unites us under a freedom army, has nothing to do with violence and will win this war for us.

This proposal has 6 parts. Part 1 is the introduction you are now reading. Part 2 is an assessment of what our freedom fighters have accomplished up to now. Part 3 describes the process for building a freedom army that unites us. Part 4 looks at Canada wide actions that become possible once we are united under our freedom army. Part 5 looks at a number of issues I feel must be addressed in any proposal that unites us. Part 6 is a wrap up with a final words.

In the freedom movement, we have leaders and followers. I refer to the former as freedom leaders and the latter as our rank-and-file.

We are the little people from the street. As a general statement, there are three groups of us: 1) the freedom fighters, 2) the sheep and covid zombies and 3) those sitting on the fence being neither freedom fighters or sheep. This proposal focuses mainly on the first group, our freedom fighters.

There is a cabal. The cabal is real. The cabal owns and/or controls most of the world. The cabal now wants absolute and total ownership and control over everything in this world including us, the little people. The cabal is making a final push for total and absolute ownership and control. This war of T&T is that final push. The depopulation agenda of the cabal will eliminate the bulk of humanity and enslave the few of us that remain. If we lose this war then we literally have no future. It is an understatement to say our situation is dire and desperate.

You can lead a horse to water but you can't make it drink. If the horse will not drink then there is no point leading it to water. This describes our freedom leaders, at least here in Canada. The horse represents our freedom leaders. The water represents what our freedom leaders must do to defeat the cabal and win this war of T&T. What happens if this horse won't drink? That is simple, it dies. That is no exaggeration.

Let's start with three facts.

1. You can't win a war if you don't know who it is you must defeat to win it.

*We don't know who we must defeat to win this war of T&T. Yes, our enemy is the cabal but who and what is the cabal? The answer is we really don't know and we haven't given it any real thought.*

2. You can't win a war if you don't have an army to fight that war.

*We don't have a freedom army. We haven't even thought about building a freedom army.*

3. We are out-gunned, out-resourced and out-classed in all ways except one. We have only one strength and that is our large scale numbers. We can only win this war by uniting with our large scale numbers, working as one with a common vision and direction in Canada and across the world.

*We are not united. We fight alone. We do not have a common vision and direction.*

We have not addressed these three facts and that leads to only one conclusion. Given we don't know who we must defeat, we don't have our freedom army and we are not united with our large scale numbers, it is impossible for us to win this war. That means everything we are doing is pointless and meaningless. Let that sink in!

We have an obvious contradiction. On the one hand, we face a real existential danger. Our situation in this war of T&T is dire and desperate, with an urgency that requires and dictates only one course of action for us; unity with our large scale numbers. On the other hand, we are not united and unity is not even on our radar. The only thing that can defeat our enemy and win this war for us is the one thing we will not do. This is a contradiction that I keep coming back to and which provides the underlying motivation for this proposal.

We are four years into this war of T&T. In Canada, we do not have any proposals, not a single one, that is even remotely aimed at ending this global war. If our freedom fighters in other countries have one then I have not heard about it. We are bankrupt of ideas of how to end this war and worse still, seemingly oblivious to this fact. What is going on?

One might think there wouldn't be any question about why and how our freedom fighters unite, that this would intuitively be natural, something automatically done by our freedom fighters. And yet we are not united and our unity remains elusive. The first question is why and the second question is how do we unite ourselves? This proposal is my answer.

This proposal is about using a peaceful, nonviolent strategy to take back Canada, our country and home, from the cabal. There is nothing subtle about the strategy. The strategy requires we fully unite all our freedom fighters in Canada and with a large number of other Canadians. We create and unite under our own freedom army. Our freedom army operates with a wartime mindset where orders are issued and followed. Our army operates with the wartime principle of might-is-right, where the strongest wins. Each action undertaken by our freedom army mobilizes our rank-and-file in each community across the country. What we do in one community is simultaneously done in all communities across Canada. We create our own political parties at all levels of government, federal, provincial and municipal. The rank-and-file in our army are ordered to vote our political parties into majority governments. This will give us the full backing of our country and all its resources which we will need to eliminate the cabal. This process must be repeated in a majority of countries of the world. All countries must form an alliance with the primary objective of eliminating the cabal and its global network. If you want a peaceful,

nonviolent means to take back our countries from the cabal then this is the only way to do it. This proposal adds up and rings true in a way nobody had thought about in the past four years.

This proposal is repetitive and will often sound like a broken record. That is intentional.

**If you think this proposal for winning this war is a pipe dream then you need to take a hard look at what you are doing now. Unity with our large scale numbers can defeat our enemy and win this war, what you are doing cannot!**

## **Winning this war – Part 2**

### **The report card**

The covid fraud began at the end of 2019 and marks the onset of this war of Technocracy and Transhumanism (T&T) the cabal is waging against us. We have now been fighting that war for four years. What have our freedom fighters in Canada accomplished? The answer is nothing meaningful and this includes the Ottawa Freedom Convoy (OFC) and the National Citizens Inquiry (NCI).

We don't know our enemy, we have no army, we have no unity. We react to the symptoms of this war (e.g. digital currency, digital identity, SOGI (Sexual Orientation and Gender Identify), 15 minute cities) but never target its cause (i.e. the cabal). We have no leadership, no discipline, no organization and no infrastructure. We fight alone and with few resources. We are always on the defense, never on the offense. We are not decentralized, we are disorganized. We have no common vision or direction. In this war, we have crippled ourselves from the start. The fact we pay no attention to such matters explains why nothing we have done, are doing or will do makes a meaningful contribution in this global war of T&T.

Unity without large scale numbers loses this war for us. Large scale numbers without unity loses this war for us. We must have unity with our large scale numbers to win this war of T&T. It is obvious what we must do to win this war. It is obvious we are not doing that. All of this leads to only one conclusion. If we continue this way then we have already lost this war. We are not fighting this war now and we have not been fighting it since we first imagined we were.

Our enemy and governments fight us with a wartime mindset and the principle of might-is-right. We feebly counter with a peace-time mindset where everyone does what they want, when they want, how they want and worse, if they want. This makes it impossible for us to win this war.

If we are to win this war then we must regroup, unite, drastically change our objectives and strategies, and then fight on our own terms. Our enemy consists of the most powerful people, families, businesses, institutions, agencies and states in this world. If we are to defeat and eliminate them, which is the only way we can win this war, then we have no choice but to unite ourselves with our large scale numbers across the world and to fight together as one with a common vision and direction. Anything less and we have lost this war.

We know what we must do to win this war. The question is will we do it?

### **Everything seems remarkable...when your expectations are zero**

On Friday evening of March 1, I joined my first Brassballs Zoom meeting. Brassballs is a feisty group out of New Brunswick. But this meeting had less than 25 people and I left after about 20 minutes. I jumped into a Maggie Braun meeting that was scheduled at the same time. After about 25 minutes, I left it because there were less than 20 people. Earlier on that day, the Freedom Rising meeting only had

about 150 people. And no, these are not leaders, most are followers. The Stand4Thee Zoom meetings held each Friday night only gets around 150 people. I recently joined, out of curiosity, two Vaccine Choice Canada Tuesday night open session meetings. Both had less than 25 people. I stopped attending the SOGI (Sexual Orientation and Gender Identity) Zoom meetings hosted by Kari Simpson each Friday because the numbers had dwindled from a high of about 60 to less than 25 after a few meetings.

I watch our alternative media shows such as The Lavigne Show and The Shadoe Davis Show. They get between 1,000 to 6,000 views per show. For a media source, these numbers are very low. Jeremy Mackenzie gets a “*relatively respectable*” over 10K views on Rumble. But in absolute terms, those numbers are nothing to brag about. Check out the number of views [NCI has on Rumble](#). A large number of NCI videos have only 1k to 10k views. Some of its videos have 10k to 100K views and a scattering few videos with numbers above that. For an action considered so highly significant by our freedom community, those numbers are awfully low.

I use Telegram, a social media platform. Most of our channels/groups have a few thousand members at best. Where members are allowed to post, less than 1% of member are active. Of those that are active, the majority are parrots parroting what a thousand other parrots have parroted in a thousand other channels. There a glut of information and nothing about meaningful actions. I occasionally use Twitter and Facebook and they too have a glut of information and no meaningful action.

The BC Rising group held a Zoom meeting on Thursday, February 29, about UNDRIP (United Nations Declaration on the Rights of Indigenous Peoples). It had about 2,200 people. The next day, in Friday’s Freedom Rising meeting, Ted Kuntz cheered by saying this “*an incredible response*”. Ted would definitely know, given his standing in the freedom community. I found this so comical and laughed to myself. Yes, 2,200 is considered an unusually large number for a Zoom meeting organized by our freedom fighters. But there are 40 million Canadians of which we have varying estimates of 5% to 30% being “*awake*”, “*freedom fighters*” or “*freedom supporters*”. So the reality of a beggarly 2,200 people from across Canada is very underwhelming!

Here is the point. Our freedom leaders do not create expectations and have no expectations. The inherent nature of how our freedom movement is structured and operates produces no meaningful results. This is why Ottawa Freedom Convoy (OFC) and the National Citizens Inquiry (NCI) are considered remarkable accomplishments; we have zero expectations. If our freedom movement in Canada had been united with our large scale numbers then OFC and NCI would be considered just a normal part of our operations.

## **The nationwide protest against the carbon tax**

A [nationwide protest against the carbon tax](#) began on April 1. This protest is another example of how we keep making the same mistakes over and over. Let’s look at this protest in terms of objectives, strategies, metrics and results. It is never a good sign when we are left to speculate about any of these four criteria and yet that is what we are forced to do here.

## Objective

The objective is the *“immediate removal of the Carbon Tax, without replacement by any other form of taxation”*.

Protests and petitions that constitute the primary action always fail. Protests and petitions might only be effective if they are a secondary or tertiary action in support of a primary action.<sup>2</sup> In the past 4 years, all our protests have been primary actions and all failed to reach their objectives.

This carbon tax protest is the primary action with writing to members of parliament being a secondary action. On its own, the protest cannot achieve its objective.

## Strategy

There is a [four point strategy](#) in the mission statement. I have many questions about the strategy and no answers. Here are a few:

- The third point is *“continue the peaceful event until goals are achieved, regardless of duration”*. Apparently there are multiple goals. Aside from getting the carbon tax canceled, what are the other goals. We don’t know.
- The protest is to go on indefinitely *“until the goals are achieved”*. What and where is the organization and organizational infrastructure (e.g. logistics, communication, food, shelter) needed to sustain this protest for the long term. We don’t know.
- For this protest to be successful, it must have hundreds of thousands of people at a minimum. How many people did the organizers expect to man the protest lines? We don’t know. How many showed up? The pictures I am seeing indicate there are no more than a few hundred people.
- Other than show up and stand around, what are protesters supposed to do? We don’t know.
- The protest will certainly inconvenience and anger drivers but how will it apply pressure on our government leaders so that they take action? We don’t know.

## Metrics

How will the success or failure of this protest be measured? We don’t know. The organizers have not defined the metric(s), we are left to speculate.

<sup>2</sup> Assume our government in Canada is sued for its heavy handed overreach in the covid mandates and, throughout the legal proceedings in a courtroom, a protest is organized outside the courthouse. In this example, the legal proceeding constitutes the primary action while the protest outside the courthouse is a secondary action in support of the primary action.

## Results

The *'result'* criteria has two parts to it: 1) before any action is commenced, what results do the organizers expect and 2) when the action is over, what are the actual results? Having answers to both parts is normally how we learn about what works and what does not work. If we want to improve then we must assess and learn from our mistakes. This is common sense.

What expected results do the organizers have for this carbon tax protest? Is the protest based on little more than wishful thinking and hope? Or do the organizers have a comprehensive plan of action? We don't know.

When the dust has settled and we know the fate of the carbon tax, what role will the protest have played? We won't know. Well, that is not entirely true.

## Summary

The intention behind the carbon tax protest is good but, based on what I understand, the implementation is terrible. This is a pattern we have seen in the overwhelming majority of our initiatives/actions to date. For these reasons, I personally will not participate in this protest and I cannot support it. It is a poor use of our people, precious resources and good will. If the carbon tax is eventually canceled then it will not be because of this protest.

This proposal offers a much more effective way to counter the carbon tax and that is by mobilizing our rank-and-file in their own community, with every community in Canada fighting against this tax. As a simple example, we order our rank-and-file to flood the riding/community office of every single federally elected member of parliament with rotating member sit-in and broadcast this nationwide action 24/7. This will become clearer once you have read this proposal.

## The cabal

Who is our real enemy we must defeat and eliminate to win this war of T&T? Let's try to put a face to the cabal.

It is the State of London, the Vatican State and the State of Washington DC. It is the central banks of the world and the Bank of International Settlements. It is the World Economic Forum, the World Health Organization and the United Nations. It is Google, Facebook, Johnson & Johnson, Pfizer, Palantir, Blackrock, Vanguard and State Street. It is the hundreds of companies listed as supporters on the World Economic Forum's website. It is the CIA in the US that has been weaponized against us little people. It is the Rothschilds, the Klaus Schwabs, the George Soros, the Elon Musks, the Donald Trumps and the Bill Gates of our world. It is every trillionaire and billionaire. It is every Jewish Zionist that has a catastrophic control over our governments and our lives. It is Bnai Brith, the Anti-Defamation League and the Canadian Anti-Hate Network. It is the most powerful people, families, businesses, institutions and agencies that are waging their war of Technocracy and Transhumanism against us, the little people.

This is the face of our real enemy. This is the face of the cabal, those I refer to as the elite criminals, that we must defeat and eliminate if we are to win this war.

It will overwhelm our freedom groups to think of what they must do to just eliminate Blackrock and it's CEO Larry Fink – one company and one person. Our freedom groups fight alone. Fighting alone, the challenge of eliminating just this one company reveals just how insignificant our solitary freedom groups are. Now picture our solitary freedom groups, with no resources, up against the entire might of the cabal's global network. I don't know about you, but the utter absurdity and futility in that imagery, a solitary ant versus a pack of hyenas, highlights the self-imposed impotence of our solitary freedom groups. It makes me roar with laughter. But that is the reality about our freedom groups today in Canada.



## Winning this war – Part 3

Our unity will never be achieved through a consensus from the leaders of our many freedom groups. It is only through the sheer force of will from the National Council (see step 1 below) and an overwhelming demand for unity from our rank-and-file that we will be able to unite all our freedom groups across Canada.

The question is, how do we start that process, how do we motivate our rank-and-file to demand our unity across Canada? The answer is we must build our freedom army. Our unity will only come about under the umbrella of our freedom army. We already have the large numbers in our rank-and-file needed to build and lay the foundation of our freedom army. What is lacking is vision and commitment to do that. So uniting is really about the process of creating the National Council and building our freedom army. Here are the key steps for making that happen:

1. Select the leaders for our freedom army. Create the National Council.
2. Make our Canada wide broadcasting network operational.
3. Create an expectation for unity among our rank and file, all across Canada.
4. Create a demand for unity from all our rank-and-file, all across Canada.
5. Define the organizational infrastructure needed to support our freedom army.
6. Build our freedom army.

### Step 1 – Select the leaders for our freedom army

The majority of us need leadership and direction to fight this war of T&T. That leadership and direction will come from our freedom army. But who gives our freedom army its guiding vision, direction and priorities? That is done by the top commanding unit in our freedom army that this proposal names the **National Council**.

This proposal structures our freedom army by nation, province, region, district and community. There are leaders/councils at each level with the top being the **National Council**. The councils and the number of members on each council are addressed in step 5 (see page 11).

All businesses, organizations and armies are led/directed by a top group of people. Our freedom army will be no different. Our strength is our large scale numbers and we must give the responsibility of organizing and mobilizing our large scale numbers to capable people. The **National Council** is a small group of Canadians who are selected on the basis of merit to lead our freedom army.

An initial list of candidates for the **National Council** has been identified. These candidates have been contacted and asked to sit on the **National Council**. Their response, to accept or decline, will be posted on our website.

***The ultimate or primary objective of the National Council must be to make very clear who our enemy is, with the goal of defeating and eliminating our enemy. The primary strategy used by the National Council to achieve this objective must be unity with our large scale numbers, in Canada and across the world. This objective and strategy must be the same for every National Council in every country of the world.***

## **Step 2 – Make our Canada wide broadcasting network operational**

How do we get that our unity message out to our rank-and-file? We already have a [Canada wide broadcasting network](#) at our fingertips. The concept is simple enough. It is about harnessing the collective power of all our websites and social media channels to create an improvised broadcasting network that can broadcast our messaging 24/7. It does not require additional resources on our part. The challenge will be in getting from our freedom leaders the commitment and discipline to make this network operational. Our broadcasting network is critical to the success of this unity project.

We have hundreds of freedom groups in Canada. All have websites and/or social media channels to get their own messaging out. These websites and social media channels are already up and running. What we need is to get them working together so they broadcast the same/identical unity messaging. For example, all websites must create a new web page named UNITY and the unity messaging/contents of that new web page will be identical for all our websites. In addition, all social media channels from these groups will begin broadcasting the same unity messaging. The **National Council** is responsible for issuing the information/content to be broadcast.

This unity proposal will contact all our freedom groups, hundreds of them, and demand they join our broadcasting network. We are here to win a war. Those freedom groups that are truly committed to winning this war will join and make their websites and social media channels part of our broadcasting network.

Making this broadcasting network operational serves two purposes: 1) to broadcast unity messaging across Canada and 2) to identify who is and who is not our ally. We consider those that join our ally. Those that do not join are not our ally.

A broadcasting network is different from a communication network. In a communication network, communication is bi-directional, being sent and received. In a broadcasting network, communication is uni-directional, being sent but never received. Ideally, this unity proposal would be better served by a communication network. Unfortunately, we don't have a communication network just yet. However, this proposal can easily make do with a makeshift broadcasting network that harnesses the collective power of all our websites and social media channels.

If you think about it, this makeshift broadcasting network effectively becomes a decentralized network and the only way for our enemy to shut it down is to literally shut down the internet.

### **Step 3 – Create an expectation for unity**

The first step is to create an expectation of unity in our rank-and-file across Canada. The key to doing this is to make our broadcasting network operational and to begin broadcasting 24/7 unity messaging to our rank-and-file. We begin by directly contacting hundreds of our freedom groups in Canada. The Freedom Rising website lists the name of about 450 different websites, the majority of which are Canadian. This will provide us with the initial list of freedom groups that are expected to join our broadcasting network. The end goal is to contact every one of our freedom groups. Each group that joins is expected to help recruit the remaining groups in Canada. During this recruitment phase, the aim of broadcasting unity messaging 24/7 is to get our rank-and-file to start thinking about our unity in everything they do. We want them to think, talk and preach unity!

As more of our freedom groups join our broadcasting network, this will increase the coverage of our unity messaging across Canada. Expectations for unity among our rank-and-file will increase in direct relationship to the number of groups joining this network. When hundreds of our freedom groups are broadcasting the same unity message then we can be absolutely certain our rank-and-file will take notice and expect us to unite.

### **Step 4 – Create a demand for unity**

This step, transitioning from an expectation to creating a demand for unity from our rank-and-file will begin once a to-be-determined number of our freedom groups have become part of our broadcasting network. This will be the challenge, changing an expectation into a demand for unity from our rank-and-file. The **National Council** will be tasked with the messaging that creates a demand for unity. This is critical because it is this demand for unity coming from all our rank-and-file that will create the pressure needed to commit all our freedom leaders/groups to unite. Unity will not come by politely asking our freedom leaders/groups. Unity will only happen when there is unrelenting pressure from our National Council and our rank-and-file that obligates or forces our freedom leaders/groups to unite.

Our progress can easily be charted by counting the number of freedom groups that become part of our broadcasting network and build our freedom army. The ones that join are our allies. The ones that do not join are not our allies. Both expectation and demand for unity in our rank-and-file will increase in direct relationship to the number of our groups that join our broadcasting network.

### **Step 5 – Define the organizational infrastructure for our freedom army**

The organizational infrastructure to be defined for our freedom army will reflect the initial types of operations it will be involved in. Initially, they will be limited to Canada. International operations with other countries will be something done at a later stage.

Our freedom army boils down to organizing and mobilizing large numbers of our rank and file. The organizational infrastructure we need must be able to support and sustain this type of action. Our freedom army must have structure and organization that is centered on the fact we currently have few

resources for fighting this war. Our rank-and-file cannot afford to go running around Canada, the US and South America like Chris Sky. They will be most effective fighting in their own community. By using the community as a core unit, our freedom army can be structured according to country, province, region, district/city and community. In other words, we use the structure our rank-and-file already understand and we avoid using unfamiliar military terms like platoon, division and company.

I propose our rank-and-file in each community are directed and led by a **Community Council** (CC). All communities (CCS) within a district or city will be directed and led by a district/city council (DC). All **District Councils** (DCS) within a region will be directed and led by a **Regional Council** (RC). All **Regional Councils** (RCS) within a province will be directed and led by a **Provincial Council**. All **Provincial Councils** (PCS) in Canada will be directed and lead by a **National Council** (NC). This structure will reflect the chain of command. Orders issued by the **National Council** are transmitted from the **Provincial Councils** down to the **Community Councils** which then issue the orders to our rank-and-file.

We must know how many of our rank-and-file we can organize and mobilize. This means our rank-and-file must register with our freedom army. This is how every business and national army operates. We are in a war and our freedom army cannot mobilize if we have no clue who our rank-and-file are and how many they are.

Currently, this proposal recommends registration takes place at the community level, by the **Community Council**. The **Community Council** then reports to higher councils only the total number that have registered, but not their names or contact information.

Many of you will suspiciously ask why must you register? If we don't know who and where you are then how can you be called upon to mobilize with **Street Army Canada**. If you don't register then you will not be part of **Street Army Canada**. Suit yourself. In that case, you can continue to fight alone with no resources and with no results to show for it.

The structure of our freedom army reflects how Canada is structured with provinces and regions. Other countries can substitute the names they use to structure themselves.

It is suggested the **National Council** should have 9 or 11 members while all other councils should have 5 or 7 members. Odd numbers ensure there will be a majority in making decisions.

This proposal will select the members on the **National Council**. The **National Council** will be tasked with selecting members to the **Provincial Councils**. In turn, the **National Council** and the **Provincial Councils** will be tasked with selecting members to the lower councils. The chain of command in our councils and the means to reach our rank-and-file means we must create a Canada wide communication network. Just as this proposal is about establishing a broadcasting network so too is about establishing a communication network using multiple existing technologies.

## **Step 6 – Build our freedom army**

It is the **National Council** and **Provincial Councils** that will be tasked with actually building our freedom army. The **National Council** provides the guidance/direction and then works with the **Provincial**

**Councils** to implement that guidance/direction. As such, building our freedom army is about registering our rank-and-file from across Canada and starting the process of training our rank-and-file to engage in common actions across Canada.

## **Street Army Canada**

You cannot fight a war without an army. One of the key objectives to this proposal is to start the process of uniting us, which in turn means starting the process of building our own freedom army, an army made of us little people from the street. I refer to our freedom army as “*Street Army Canada*” but the actual name will be decided by the **National Council** that leads our army.

**Street Army Canada** is about discipline, infrastructure, leadership, logistics, objectives, organization, recruitment, registration, strategies and everything else an army needs to mobilize and sustain its operations. You cannot fight a war if you do not have an army or the organizational infrastructure to support that army.

As is explained in part 4, **STREET ARMY CANADA WILL NOT PROMOTE, SUPPORT OR ENGAGE IN VIOLENCE!** Nevertheless we adopt the vocabulary of war to make it very clear that we are fighting in this war of T&T. The word “*army*” is significant in the vocabulary of war and reflects our motivations and intentions in fighting this war of T&T.

## **Street Army World**

This global war of T&T makes clear that we will never be safe if we do not eliminate the cabal and its global network. A united Canada cannot win this war on its own. **Street Army Canada** is just a first step in building the global freedom army and global organizational infrastructure we must have to sustain our fight in this war of T&T.

This war requires we unite ourselves across the world. What we do here with **Street Army Canada** is to lead by example, to demonstrate what must be done in all countries of the world. If we are to defeat and eliminate our enemy, each country must create its own street army (e.g. Street Army France, Street Army Germany, Street Army USA). **Street Army Canada** must ally with all our street armies and together we will create Street Army World. We must coordinate and mobilize together as one, with a common vision and direction. This is the only way we are guaranteed to have future.

## **Funding Street Army Canada**

This proposal establishes 6 steps to building unity under **Street Army Canada**. **Street Army Canada** itself only occurs in step 6 and this is where our rank-and-file make a financial commitment.

Initially, our only source of funding will be what we can give ourselves. So when our freedom fighters register and join **Street Army Canada** then each agrees to fund it. Our rank-and-file will be expected to commit a to-be-determined monthly contribution (e.g. \$1, \$5, \$10 or \$20). Assuming one million of our

rank-and-file contribute \$1 a month then that amounts to one million dollars a month. To defeat and eliminate the cabal, our rank-and-file in Canada alone must be over 10 million strong.

The members on our **National Council** must commit themselves to **Street Army Canada** on a full time basis. They can only do that if we pay them a salary. The salary will not be high and it is to-be-determined. But it must be a livable salary that readily can support a family.

Different ways of conducting financial transactions will be considered because our government has demonstrated it will break our laws and our freeze bank accounts.

## The catch

There is a catch to this unity proposal. It requires a commitment from a majority of our freedom websites. Our freedom websites are managed by our freedom leaders. This proposal openly states many of our freedom leaders do not want unity. So why then would they consent to their websites being used to promote and build unity as is demanded by this unity proposal?

There will be freedom leaders who will join and commit to this unity initiative. The question is how many? These are the one who have begun to recognize or have already recognized there is little they can accomplish when they fight alone and with no resources. They understand we must drastically change our tactics. This proposal is giving them that change and they will accept this offer. These are the ones we focus our time and energy on, who will form the core of our freedom army. Their websites are the key to getting our unity messaging out across Canada to our rank-and-file. In turn, we will get our rank-and-file to apply unrelenting pressure on all our freedom leaders that remain uncommitted to our unity.

## The metrics

We can monitor the progress of this proposal by counting the number of our freedom web sites that commit to it. This will be a strong indicator of who is truly committed to winning this war.

What if the majority of our freedom leaders reject this proposal? The answer is simple. We can then definitively conclude our freedom leaders are not committed to winning this war of T&T and that their priority is their petty turf wars (see page 25).

For this unity initiative to succeed, an overwhelming majority of our freedom leaders/groups must commit to it. If this unity proposal is successful, we will have created our very own powerful broadcasting network that covers all of Canada, from coast to coast. We will also have created our own freedom army, **Street Army Canada**.

We will maintain a list of all groups that join our network and **Street Army Canada** as well as the groups that refuse to join. Those that join are our allies. Those who do not join are not our allies. We are fighting a war. At the least, we give our time and money to those who fight with us and deny it to those that do not fight by our side.

## Winning this war – Part 4

### The what of unity

Our freedom groups are engaged in hundreds of actions across Canada. There are some good ideas behind a few of them. But what makes all of these actions of little value is they have no reach and no muscle. The National Citizens Inquiry (NCI) and its report is an example of a good idea. Unfortunately, most Canadians have not heard about either and, unless something changes, that report is destined for the dustbins of history. We must not allow that to happen.

Every sector of our economy in Canada and economies throughout the world are controlled by the cabal and its global network. We are highly dependent upon the cabal's network for most everything we need to survive and live on a day-to-day basis. The cabal has a stranglehold on us and the covid fraud demonstrated just how vulnerable all of us are across the world. To break that stranglehold and win this war, we must eliminate the cabal and its network. However, that represents only half our battle. The other half of that battle will be to replace the cabal's network with our own network that serves our needs and interests.<sup>3</sup> But let's not get ahead of ourselves.

This part of the proposal is about what we do with unity and our large scale numbers. As mentioned, there is nothing subtle about what we do. In every action we undertake, we use our large scale numbers to steamroll and overwhelm our enemy in Canada and the world. The **National Council** prioritizes initiatives and those selected for action are executed by our rank-and-file simultaneously across Canada. What we do in one community, we simultaneously do in all communities across Canada.

There are three broad classes of action with large scale numbers that **Street Army Canada** will employ: 1) establish a street presence, 2) influence policy and 3) make policy.

### Establish a street presence

There are millions of freedom fighters and supporters here in Canada. We pass each other every day in our daily activities. We are surrounded by allies. But we can't identify them and they can't identify us. We are invisible. That must change. Establishing a street presence is about letting all Canadians know who we are and what we are about. We are not a fringe minority as our governments claim and we will prove that by becoming visible.

What makes the sheep and covid zombies stand out in our communities? When the fraudulent covid mandates were lifted, the sheep and zombies continued wearing the face diaper (i.e. the mask). A few continue wearing them even today. The face diaper is their badge (of shame) and they stand out like a sore thumb.

We need to stand out. We must establish a street presence, something that makes each of us visible in public. It could be as simple as a symbol on badge or sign we put on our coat, hat or bag. When we unite under **Street Army Canada**, our rank-and-file should proudly display a badge with the name **Street Army Canada** on it. We are in a numbers war. Our rank-and-file must be able to see our numbers for themselves.

Establishing a street presence means more than just being able to visibly identify our rank-and-file on the street. It can include ordering our rank-and-file to plaster our posters throughout every community. What we do in one community, we do in all our communities across Canada. It can include ordering our rank-and-file to host community workshops, attend and/or speak at every city hall meeting in every community. Imagine how powerful a message we will send if we put Maggie Braun's [KICKLEI initiative](#) into every community in Canada. **Street Army Canada** can do that.

There are many ways to establish a strong and ongoing street presence in every community across Canada. Our **National Council** prioritizes initiatives and then, for each initiative, orders our rank-and-file to action in every one of our communities. What we do in one community, we simultaneously do in all communities across Canada.

With a strong and ongoing street presence, legacy media will be hard pressed to ignore us. A street presence combined with our broadcast network will make it extremely difficult for legacy media to ignore and distort our messaging. This will go a long way towards effectively countering the dogma and propaganda from our enemy.

Let's create and maintain a strong street presence. Seeing is believing. It will be inspiring and motivating to see our large scale numbers as we go about our daily lives in our own communities.

## **Influence policy**

We do not yet have our own freedom political parties. Until then, we must be able to influence political parties at all levels of government (municipal, provincial and federal) in Canada. We also need to be able to reach all the decision makers including doctors, scientists, police, judges, lawyers, etc.

The squeaky wheel gets the attention and we aim to use **Street Army Canada** to get a lot of attention.

Here is an example of how **Street Army Canada** can mobilize our rank-and-file to get Canada wide coverage and attention for the NCI report. Keep in mind this is not just about influencing policy. The process described next can be applied to any and all of our actions. Regardless of the action, what we do in one community we simultaneously do in all communities across Canada.

Assume the **National Council** has made getting the NCI report out across Canada a priority. We want to swamp all authority officials in Canada with this report. The **National Council** defines the objective, the strategy and the metric. The starting or initial objective is to simply deliver the NCI report to all our politicians, all our doctors and health care workers, all our law enforcement workers and all legal system workers with the NCI report. The strategy is to order our rank-and-file to distribute the NCI report in every community across Canada. The measurable metric is simply the total number of people targeted



to receive the report. If a to-be-defined percent (e.g. 95%) of targeted people receive the report then the objective is met (the initiative is successful) otherwise the objective is not met (i.e. the initiative fails).

The report will be delivered in stages<sup>4</sup>; to every doctor in Canada in the first stage, to every judge in the second stage, to every law enforcement officer and chief of police in the third stage, etc. The **National Council** issues orders to **Provincial Councils** (PCS) that the NCI report is to be distributed to all doctors in their respective provinces. The PCS will have an administrative group compile a list of doctors that the report is to be delivered to. The orders and doctor list will then be transmitted down through the chain of command from PCS to **Regional Councils** (RCS) to **District Councils** (DCS) and finally to **Community Councils** (CCS). The CCS will then issue these orders with the list of doctors to our rank-and-file in its community. Our rank-and-file must then deliver and provide confirmation of delivery of the NCI report to those doctors.

The initiatives undertaken by **Street Army Canada** are not necessarily new. What is entirely new is how we action each one with our large scale numbers. Our **National Council** prioritizes initiatives and then points the large scale numbers of our rank-and-file at where they are to go and what they are to do. Again, what we do in one community, we simultaneously do in all our communities across Canada. This is how we give each of our actions reach and muscle. It can be particularly effective in getting around the widespread censorship we now face. We drive home our actions and messaging with our sheer numbers.

There is nothing new about a chain of command. It reflects how every big business and army operates. What is new is that we are applying this model to give critically needed structure and organization to our freedom fighters. This is what unity is about. This is what unity looks like. As you can see, this has nothing to do with violence.

## Make policy

Klaus Schwab bragged that he stacked half of Justin Trudeau's cabinet with his young leaders. Trudeau being one of them. Two can play that game. We will do just that plus significantly raise the stakes.

The idea here is simple. We become the government and we then make might-is-right policy that reflects our interests. This is majority rule – highly questionable during peacetime, absolutely necessary during wartime! We create our own political parties, at all levels of government, and our rank-and-file are ordered to vote them into a majority government.

Our governments at all levels have been subverted by Klaus and his horrific gang of parasites, pedophiles and psychopaths. The only way to restore our governments is for us to form a majority government. That only happens when we have unity with large scale numbers and **Street Army Canada** orders our rank-and-file to vote our own political party into government with a majority vote.

I have listened to a number of proposals from our freedom groups about how voter turnout for elections at the municipal and provincial levels is very low. It is therefore quite easy to win elections by organizing and mobilizing relatively small numbers of people at the municipal and provincial levels. I don't know about the federal level but the principle of numbers still applies. What is proposed here is how to generate the numbers that promises to elect our own political parties.

What is **Street Army Canada**? It is the large number of us in Canada who do not accept the cabal's One World Government and its depraved ideology of T&T. We recognize the only way we can defeat the cabal is by uniting ourselves with our large scale numbers. Unity with large scale numbers is our primary strategy and we adopt that strategy in every action we undertake, including restoring our political system to represent our interests and not the interests of the cabal. **Street Army Canada** is what unites us and gives us direction.

We are in a war and that war requires we adopt a war-time mindset and the principle of might-is-right. A war-time mindset means we understand orders are issued and followed. Our rank-and-file are ordered to vote our own political parties into office. This is how we use the principle of might-is-right and our numbers to our strategic advantage. If you want to win this war without violence then this is the how we do it. It is all about our numbers and only about our numbers. No numbers? No results!

As I said, there is nothing subtle about our strategy. We use our numbers to steamroll our own political parties into office.

## **The fence sitters**

As was mentioned, there are three general groups of people with the third group being the fence sitters. We will need the fence sitters to come on side with us and they will play a vital part in our fight against the cabal. Once we have united our freedom fighters then will must immediately begin the process of having the fence sitters unite with us. How do we get them?

If I am correct, our freedom fighters and the NCI report share something in common; the fence sitters know nothing about us and probably are not even aware we exist. So the first step in bringing the fence sitters on side with us is to let them know we exist. That is where our establishing a street presence and influencing policy comes in. Our street presence across Canada will make the fence sitters realize just how large our numbers are. Without having to say anything, our large numbers will be a very compelling and persuasive argument for the fence sitters. Needless to say, the sheep and covid zombies will also take notice.

Another way of letting the fence sitters learn about us is via our Canada wide broadcasting network that includes all our social media channels. It is inconceivable that fence sitters who use social media will not come across our social media channels. We will flood our fence sitters with our messaging on social media.

Most fence sitters will respond well to information and facts we share. It will certainly help to sway them when they see we are united, are flooding our social media with our messaging and they see us everywhere in public.

## Steamrolling across Canada

How angry are you about the depraved agendas being forced down our throats? Does the child abuse also known as the butcher-and-sterilize your child trans agenda do it for ya? Does the 100+ different sexes for your kids do it for ya? Does the child-get-your-clot/kill shot-but-don't-tell-your-parents do it for ya? Does the grooming-for-pedophiles child sexual indoctrination in elementary schools do it for ya? Do the immigrants flooding our country that don't give a shit about our values, traditions and culture do it for ya? Does the engineered white ethnocide in our country do it for ya? Does the engineered skyrocketing inflation, skyrocketing food prices and unaffordable housing do it for ya? Does the pointless carbon tax or the fraudulent Online Hate Crimes (i.e. censorship) Act do if for ya? Does our corrupt federal government and traitorous top politicians do it for ya? What does it for ya? If you are not angry, as in seething with anger, then there is something is seriously wrong with you.

We can't tackle all these agendas and crises at once. To be effective, we must prioritize them and tackle them in their order of priority. That is the responsibility of the **National Council in Street Army Canada**. When our **National Council** gives us a target then the chain of command kicks in and our rank-and-file are mobilized to converge on that target. We will be much more effective this way instead having each of us running around, like chickens without heads, doing completely different things. Our aim, in everything **Street Army Canada** does, is to literally swamp and steamroll over our enemy with our numbers. This means we must be organized and coordinated in Canada. Moreover, the intention must be to synchronize our actions in Canada with all other countries in the world.

This is what it means to unite with our large scale numbers, with a wartime mindset and with the principle of might-is-right. This can only be done under **Street Army Canada** and our street armies of the world. Our turf wars and fighting alone are simply not up to the challenge of the high level of organization, coordination and synchronization we must have to defeat the cabal and win this war.

Let me repeat, if we want to defeat our enemy and win this war of T&T with peaceful and nonviolent means then this is how we do it in Canada and across the world.

## Accountability

We want to hold accountable the people who imposed the fraudulent covid mandates on us and all the economic, financial and personal harm these mandates caused us. Millions of us have been killed by the clot/kill shots (i.e. "*covid vaccine*"), and hundreds of millions have suffered serious injury. These fraudulent covid mandates destroyed our businesses, families and lives. Trudeau, Freeland, Lametti and all other traitors to Canada caused us real harms. They are complicit in murdering Canadians.

Accountability can only happen when we become the government and that happens by electing our own political parties into power with a majority at all levels of government. Then our political parties must exercise sheer strength of political will and might to force through accountability. Our legal system protected these traitors during the covid fraud and our legal system will try to protect them when we bring them to account. The law is what our courts say it is and our courts have been subverted. We will force our legal system to be the justice system it was meant to be.

Accountability means stripping these traitors of their pensions and assets they acquired during the fraudulent covid mandates. Accountability means putting these criminals behind bars for a long period of time, if not for life. Accountability means imposing heavy fines and penalties on the middle men who did great harm to us. Accountability means reinstating the death penalty for treason. Justin Trudeau, Chrystia Freeland and Jagmeet Singh are traitors to Canada.

Currently, a few of our freedom groups have launched lawsuits in an attempt to hold our government accountable. They are joke. Even if they are successful, most of what might be awarded will come from public purse. I understand the Accountability Project will try to hold Trudeau personally responsible. Trudeau is now worth hundreds of millions of dollars. Anything the Accountability Project might win from Trudeau will be chump change to Trudeau. Not a single person will have their pensions and assets effected. They will not spend any time behind bars. The cabal will protect Trudeau and Freeland, giving them plumb jobs once they leave public office.

All other countries must adopt the same aggressive stance on holding people who harmed us to account. We can show leeway and mercy on those near the bottom. But those at the top and the middle must pay heavily for their crimes and treason against us.

Without **Street Army Canada** and the street armies of the world, we cannot and will not have any expectations for accountability. Without expectations, the few table scraps and bones tossed our way will seem remarkable; the word that comes to my mind is "*pathetic*".

## Monetary reform

Monetary reform is about breaking our dependencies on the cabal and its global network. One of the first things we must do in Canada and every country of the world is to force through monetary reform.

Our governments in all countries now borrow money from the world's central banks that are owned and controlled by the cabal. As a direct result, the national debt of all countries is unsustainable and unpayable. This is causing our global financial systems to collapse. This is the real cause of the conflict and crises we are seeing in our economies and our lives. Covid was never about an alleged virus, an alleged disease and a pandemic; all were fake. The covid fraud had nothing to do with protecting public health and safety. The covid fraud was simply a crude but brilliant ruse to divert our attention away from our collapsing global financial system. This is why the cabal is rushing its tyrannical plans for One World Government under the depraved ideology of T&T. But that is not point here.

A country that does not control its money supply and monetary policy is a country that has no control over its economy and cannot provide for the needs of its citizens. All countries in the world have lost this control to the cabal. Canada lost this control when Pierre Elliott Trudeau, the alleged father of Justin Trudeau, sold us out to the cabal.

Prior to Pierre Trudeau, our governments (e.g. federal, provincial and municipal) borrowed money from the Bank of Canada. Our governments debt was peanuts and we owed it to ourselves. Starting with Pierre Trudeau, our government debts began to steeply accumulate, never going down, always

rocketing upward. This is reckless and gross mismanagement of Canada's finances and resources that only benefits the cabal and severely impacts all Canadians.

Money our governments are forced to borrow is an accounting entry. What that means is the central banks of the cabal create money from thin air. It is not their money and it does not cost them anything to create that money. But in return, the cabal demands we give it heavily discounted access to our hard resources such as minerals, fresh water and wood. In Canada alone, we unnecessarily pay tens of billions of dollars of our hard earned money in interest to the cabal each year. The cabal demands we pay more and higher taxes because our debt at all levels of government is unsustainable and unpayable. This is criminal theft and, under our current legal system, we cannot prosecute the cabal because it has written itself full legal immunity from prosecution. When we form the government and make policy then that means we stop giving the cabal our money and we revoke their legal immunity.

The cabal dictates Canada's monetary policy and our governments simply implement them. This is why our governments in Canada are so deeply indebted. The cabal leverages this debt to control our governments and our personal lives (e.g. austerity measures). It should not be this way. We can and must end this theft. For Canada, monetary reform means restoring to the Bank of Canada the responsibility of controlling the Canadian money supply and monetary policy.

Figuratively speaking, the cabal has the keys to the world's money printing presses. When you and I need money then we must earn it through a salary or self-employment. Not so for the cabal. When the cabal needs money it simply prints it, again figuratively speaking. That puts us at a huge disadvantage in this war of T&T. The cabal prints the money to pay its puppets to fight us on a full time basis. We, on the other hand, cannot fight back on a full time basis because we have jobs and other responsibilities that occupy a big part of our day. To win this war we must start thinking about how to tip the balance in our favor. The short answer is we must rip the world's money printing presses from the hands of the cabal. That starts by taking control over the creation of our money supply and monetary policy here in Canada. This is what monetary reform is about.

Monetary reform is not something new here in Canada or any other country. Many have talked about the need for it. [COMER](#) was one such action here in Canada. Unfortunately, it did not succeed.

All you need to understand for now is that monetary reform, in Canada and every country of the world, represents a big part of "*ripping the world's money printing presses*" from the hands of the cabal. If we are successful with monetary reform then that means Canadian resources the cabal is currently using to fight against us will instead become ours that we can use to fight the cabal. Each country that achieves monetary reform will likewise take back critical resources the cabal currently uses against us and that we can then use to fight against the cabal.

We must have monetary reform in Canada and every country of the world.

This proposal has been hammering away on the fact that our only strength is our large scale numbers. We have lost control of everything we need to survive to the cabal so we start with the only strength we have, our numbers. Monetary reform means we take a big part of that control back from the cabal. When that happens then our strength will become so much more than just our large scale numbers.

Monetary reform alone, in Canada and all countries, will not win this war for us but it will significantly tip the balance of this war in our favor.

There is nothing subtle about what we must do to achieve monetary reform; numbers matter and might is right.

## **The scale and scope of our war**

Monetary reform is but the first step in defeating the cabal. There are many things we must do to strip the cabal of its ill gotten gains. I list a few in the section titled "*What do we do once the street is united*" in [an older blog post](#). We must repudiate Canada's national, provincial and municipal debts. We were forced into unsustainable and unpayable debt to the cabal and this means that is all odious debt. We stop paying it! We eliminate our private banks such as Bank of Montreal, CIBC, Royal Bank and Toronto Dominion in replace them with public banks. The cabal and its network hides its money in tax havens and foundations. We must therefore eliminate both tax havens and foundations.

All you need to understand at this point is what these things represent is "*ripping the world's money printing presses*" from the hands of the cabal. This is the Achilles Heel of the cabal. We are in a war where might-is-right and this is our declaration of war against the cabal.

This is where things will most likely get a lot worse for us before they get better. We are going for the cabal's jugular vein and the cabal will be ruthless in its response. We will need more than **Street Army Canada** and our other street armies of the world to counter the cabal and back us up. We will need real armies with real guns, tanks, battleships and fighter jets to back us up.

That is why we must become the government with the full weight and power of our countries behind us. When we become the government, with the full support of **Street Army Canada** and our rank-and-file behind us, then all resources in Canada, including our Canadian National Army, can be brought to bear against the cabal. Obviously Canada cannot stand alone against the cabal and it's global network. We must have our political parties in power in the majority of countries across the world so that the collective armies and resources of all our countries can be brought to bear against the cabal.

If we want to win this war then you now see the true scale and scope of what we must do. You will now understand the futility of our turf wars, our fighting alone, with no resources. You will now see why everything we have done up to now is pointless and meaningless. You will now see why we have not even been in this war despite what we have imagined ourselves doing. We have only one strength and we are not playing to our only strength.

## **Friend or foe**

One of the goals of this proposal is to make clear to all of us who our allies are in this war and who our foes are. A separate list of our allies and our foes will be maintained for all of us to see. Expect to see people and groups we think of as freedom fighters on the list of our foes.

Our allies are those who recognize unity with our large scale numbers is the only way we win this war. Without question, they will automatically join and become part of **Street Army Canada**.

Our foes are not just the cabal and it's global network. Our foes are also anyone and any group that undermines and/or sabotages our unity with our large scale numbers. They are easy to identify. They are the people and groups who come up with excuse after excuse for why they will not unite with us. These are the one that will continue to fight their petty turf wars and for their sliver of the spotlight. They masquerade as freedom fighters all the while doing nothing to unite us.

## **No charter challenges**

The covid fraud and the [Coutts travesty of justice](#) showed the Canadian Charter of Rights is subject to the whims of our judiciary and government. Sections 1 and 24 allows them to claim they are right, we are wrong, end of legal argument. The charter gives privileges, not rights. Charter challenges are very expensive and priced out of reach for 99% of Canadians. If we want to quickly squander **Street Army Canada's** resources and demoralize our rank-and-file then charter challenges and defences are definitely the way to go.

Sections 1 and 24 allow the cabal and it's puppets like Trudeau to throw us the occasional bones. But once we gain real traction against the cabal then sections 1 and 24 guarantee any legal challenge we mount will fail and that failure will have nothing to do with the merits of our challenge. **Street Army Canada** must stay as far away from the charter as possible.

## **No one fights alone and we have each others back**

**Street Army Canada** is about fighting together as one, with a common vision and direction. **Street Army Canada** means we stop worrying about being alone and how our families are supported if something happens to us. With **Street Army Canada**, we have each other's back. If you are illegally arrested, imprisoned and made a political prisoner we, fellow members of our rank-and-file, assume responsibility for supporting and caring for your family. **Street Army Canada** guarantees you are not lost and forgotten in prison and we are committed to getting you out of prison. With the benefit of hindsight of what happened to the Coutts men, we know what to expect from our governments. We must not fight alone and we will not fight alone.

## **The enemy of my enemy is my friend**

Our freedom groups are heavily fragmented and completely disorganized. I have observed our petty jealousies, our petty differences and our petty turf wars that keep us apart. I know a lot of you don't like each other and don't like other many other ethnic groups in Canada. It is even reasonable to believe the cabal plays us off against each other. But it all boils down to one question. Do you want to win this war?

We are not here to make friends. We are not here to be liked. We are not here to spread our beliefs and ideology. We are here to win a war. When you join Street Army Canada you set aside your differences and work together. We do not have the luxury of choosing our allies. The enemy of my enemy is my friend and ally. We unite and work as one.



## Winning this war – Part 5

There are a number of issues addressed in this part that are related to or impact our unity.

### Turf wars

Any attempt to unite our freedom groups must immediately tackle an insidious problem<sup>5</sup>. We are not united, even after four years of this tyranny of T&T in Canada. Strange that, isn't it? Unity with our large scale numbers is the only thing that can defeat this tyranny and our enemy. So what is stopping us from uniting? That problem is summed up in three words: petty turf wars.

Each of our freedom leaders imagines they have carved out their own piece of turf in our war against T&T and each leader zealously protects that imagined speck of dirt. That speck of dirt has become their objective and priority. Unity is a dirty word to our freedom leaders because it threatens their speck of dirt.

We have freedom leaders that claim they want to unite us. But their actions betray their words. If our freedom leaders had wanted unity then we would have had it by now.

### Names

Here are a few freedom groups that are fighting petty turf wars: The Accountability Project, Action4Canada, Awake Canada, BC Rising, Canada Health Alliance, Canadian Front Line Nurses, Children's Health Defense Canada, Constitutional Rights Center, Covid Care Care Alliance, Democracy Fund, Druthers, Freedom Rising, Front Line Covid Critical Care Alliance, Mama Bears, Manitoba Stronger Together, National Citizens Inquiry, Police On Guard For Thee, Stand4Thee, Vaccine Choice Canada and Veterans4Freedom.

Here are a few freedom leaders that are fighting petty turf wars: Benita Pedersen, Chris Sky, Jason Christoff, Jeremy Mackenzie, Kari Simpson, Ken Drysdale, Kelly Ann Wolfe, Maxime Bernier, Maggie Hope Braun, Mark Trozzi, Randy Hillier, Ryan Penn, Shawn Buckley, Tanya Gaw, Ted Kuntz and Vincent Gircy.

It might surprise you that a few of these people and the people in these groups are being considered as potential candidates for the **National Council**.

What these groups and people all have in common is no vision, no reach, no muscle and no interest in ending this war of T&T. They cannot identify who our real enemy is that we must defeat to win this war. They don't promote unity with our large scale numbers. They don't want to build our freedom army. They don't offer any solutions to end this war. They don't even think about how to end this war. They fight alone with few resources. It is a joke to claim our freedom groups are part of a "*decentralized*

*freedom movement*” when the reality is what they amount to is less than fragmented and disorganized. For these reasons, anything our freedom leaders are doing is therefore meaningless and pointless. Unity shines a spotlight on the fact their petty turf wars do not get us any closer to winning this global war of T&T.

### **Marcus Ray**

Do you remember the Marcus Ray and Christopher James initiative to take back Canada? The essence of this initiative was to hold our own people’s law court in one of Canada’s legal court rooms. The goal was to hold accountable traitors such as Trudeau and Freeland because our own legal system has been subverted by foreign interests and protects these traitors.

Marcus worked hard to bring us all together to support this initiative. I remember the hope, the excitement and inspiration in our social media channels covering this initiative. Marcus got a lot, and I mean a LOT, of positive attention. That did not go down well with more than a few of our freedom leaders and they sabotaged this initiative by falsely claiming Marcus and Christopher were planning violence. It did not matter that Marcus went to extraordinary lengths to say no one wanted violence, was planning violence or would use violence. While I did not agree with Christopher’s approach to law, I agreed with the intention behind the initiative.

The planned peoples court was to be surrounded and protected by patriots who understood justice and accountability will only come from us. This initiative had good reason to believe Canadian law enforcement would be ordered by the traitors, Trudeau and Freeland, to use violent means to disrupt and cancel our people’s court. If there was violence then it would come from government. This is indeed what we saw on Parliament Hill in Ottawa after Trudeau illegally invoked the Emergency Act. Many among our freedom leaders twisted this around and falsely accused Marcus and Christopher of planning violence. I listened to one particular freedom leader spew this flat-out lie and I was disgusted. But that reflects the nature of our turf wars.

Just as the Marcus Ray initiative was sabotaged by petty jealousies and turf wars from our freedom leaders, so too can we expect the same for this unity proposal.

### **Jason Christoff**

Jason illustrates our turf war problem. Jason charges \$2,000 US for his “*mind control*” workshops. He depends upon our division for his livelihood. You will not hear Jason promoting our unity or our large scale numbers. He cannot afford that because if we unite under our freedom army then that means our rank-and-file will redirect their attention and money to support nation-wide actions under **Street Army Canada**, actions that are guaranteed to produce real change. That will take a big chunk out of any money Jason currently gets from our freedom fighters in Canada. So as long as our freedom groups remained divided and disorganized, Jason can masquerade as a freedom fighter and protect his pocket book at the same time.

## **Disillusioned**

If I am correct, our rank-and-file are disappointed and disillusioned with our freedom leaders. My sense is this is why our freedom leaders have so few followers in their actions and meetings and why our freedom leaders are constantly begging for donations and volunteers.

No initiative to build unity will succeed without directly and aggressively confronting the reality of our petty turf wars. The point is many of our freedom leaders are not going to come willingly along on this unity project. They will have to be “nudged” into unity and that nudge must come, and can only come, from our rank-and-file.

## **No surprises**

And yet, none of this is surprising.

As a general statement, it needs be said our freedom leaders are the same as you and me. The only difference is they have an idea or two and have set about trying to implement them. It is very likely none of our freedom leaders have had any leadership training or experience. Doctors, engineers and lawyers are no more natural leaders than electricians, plumbers and truck drivers. Our current freedom leaders may have the best of intentions but most have demonstrated they are just not up to the challenge of leading.

It is with this understanding that many of our freedom leaders are not experienced enough to lead that we can find the answers for why we have not identified our enemy, why we are not even thinking about building our freedom army, why we are not united and why we do not have a common vision and direction to guide us in this war of T&T. It is understandable why so many of our freedom leaders have succumbed to the lure of the spotlight and have therefore prioritized their petty turf wars over winning this global war of T&T.

After four years, what is blatantly clear is that none of our freedom leaders in Canada are even thinking about how to win this global war of T&T. This is why I now refer to our freedom leaders and even our rank-and-file as [toothless chihuahuas](#); they are as ineffective in fighting this war of T&T as a toothless chihuahua.

Our freedom leaders will sneer at me and sarcastically ask how can this be a unity proposal when it openly mocks and ridicules them? Here’s my response to you. War is unforgiving, it does not reward failure. You are failing us. You are not doing anything that can win this war for us. You will not acknowledge your incompetence and impotence in fighting this war. Your ego keeps you from committing to the only course of action that can win this war for us. You must be called out and this unity proposal calls you out.

## **This is not a request. It is an expectation and a demand!**

Unity with our large scale numbers is the only way we defeat our enemy and win this war. Anything less and we lose this war.

We are not united. Let me make very clear what this means.

Whatever it is you are doing or think you are doing right now, you are wasting your time. Worse, you are wasting the time and money of those who support you. This is true of every single one of our freedom leaders and groups here in Canada. That makes every one of you that is selling merchandise (e.g. t-shirts, coffee mugs) grifters and scammers. You claim to be fighting this war, all the while nothing you do can win this war or contribute to our fight. You are alone, with no resources.

This proposal is not asking you to join our freedom army. **This proposal is expecting and demanding you join our freedom army!** This is a test that will prove to all of us where your priorities, principles and loyalties lie. How you respond will show us what side of this war you are on. If you refuse to be part of our freedom army then you are not fighting for our freedom, you are not a freedom fighter and you are not our ally.

## **This is a global war**

Canada's population is about 40 million. The world's population is about 8 billion. That means our population in Canada is about 0.50% of the world's total population. What that means is even if every single adult and child in Canada was committed to fighting against this tyranny of T&T, by ourselves, we cannot defeat our enemy and win this war.

Our freedom leaders in Canada are divided and disorganized. What exactly do our freedom leaders think they can accomplish when each fights alone as they do now? The answer is nothing. Our rank-and-file here in Canada need to step back and look at this bigger picture because it provides another perspective that illustrates just how ineffective and impotent our freedom leaders are when they fight alone.

To win this war, we must unite not only our freedom fighters here in Canada, but we must also unite and coordinate with freedom fighters in all countries in the world.

## **The vocabulary of war**

We are in a war. You cannot fight a war with a peace-time mindset and a peace-time vocabulary. The vocabulary of war includes words like army, defeat, eliminate, fight, firing squad, might-is-right, orders, sacrifice, treason and war. Adopting a wartime mindset to fight a war requires using the vocabulary of war. We must adopt a war-time mindset and the vocabulary of war.

Our freedom leaders are afraid to use the vocabulary of war. Our freedom leaders fear if we use the vocabulary of war then our governments will twist and misrepresent our intentions as being violent and extremist. As was explained in part 3, all our actions are peaceful and nonviolent. **STREET ARMY CANADA WILL NOT PROMOTE, SUPPORT OR ENGAGE IN VIOLENCE!** We are using our rights-by-law to engage in nonviolent, peaceful actions against this tyranny of T&T.

Our governments have declared us to be the enemy and fight against us. Our governments have a war-time mindset where might-is-right. Our governments twist and misrepresent everything and anything we say, regardless of whether we use a peace-time vocabulary or a war-time vocabulary.

The problem is not the vocabulary of war. The problem is our feckless freedom leaders who are afraid to use the vocabulary of war. Our freedom leaders are fearful and that fear restricts them to a peace-time mindset and a peace-time vocabulary. Their fear severely handicaps our fight.

## **Might is right**

What does the ruthless slaughter of Ukrainians, the ruthless slaughter of Palestinians and the covid fraud have in common? These are horrific crises engineered by the cabal against us, the little people. In our world, nothing of any significance happens by chance. All crises in our world are engineered by the cabal. Their rule of law is might-is-right, the strongest wins.

ANTIFA and Black-Lives-Matter were created, nurtured, funded and mobilized by the cabal to create division and conflict in our western countries. Immigration policies across Europe and North America are flooding our countries with non-whites for the purpose of making whites a minority in our own country. This is white ethnocide and it has been engineered by the cabal. Their rule of law is might-is-right, the strongest wins.

The deadly covid mandates caused more economic and financial destruction than both world wars. They were forcibly imposed on us by all levels of our governments, law enforcement agencies, our legal system and our medical system in Canada and across the world. We must build unity with our large scale numbers. We must build our freedom army. What is needed and demanded from our rank-and-file is for them to recognize the absolute necessity of and to support our unity, our large scale numbers and **Street Army Canada**.

## **What comes first, the chicken or the egg?**

For us, the little people, this war of T&T is a numbers war. Our only strength is our numbers. We can only win this war by playing to our one strength. First, we must have unity. We fight as one, or not at all. Second, we must fight with our large scale numbers, working together with a common vision and direction.

What comes first, action or numbers? Do you first start an action with a handful of people and hope it snowballs into millions of people? I refer to this as the "*snowball approach*". Or do you first bring together millions of Canadians before engaging in any action? I refer to this as the "*ant approach*".

The "*snowball*" approach is what our freedom leaders have been using for the past four years and continue using now. It has not snowballed and, for inherent reasons, it will never snowball.

The "*ant*" approach is to first bring together and organize millions of Canadians with the understanding that a large number of people, a critical mass, must be attained before any action is initiated. Once those large scale numbers have been reached then these people are to be simultaneously engaged in a common action across Canada, from coast to coast. For many reasons, a big part being egos and turf wars, our freedom leaders avoid this approach like the plague.

This proposal adopts the second "*ant approach*".

Before going into detail, we must first ask a specific question because the answer to that question dictates whether we commit ourselves to fighting this war or if we should throw in the towel and do nothing at all. The question is, do we really have the numbers in Canada?

## **Do we really have the numbers in Canada?**

In Canada, do we the numbers (of people) needed to make a meaningful contribution to fighting this global war of T&T? The short answer is yes.

As a very general statement, there are three groups of people in Canada. The first group are the freedom fighters, those who claim to be “*awake*”. The second group are the sheep and zombies who willingly swallow whatever dogma and lies our puppet governments spit out. The third group are those sitting on the fence, neither in the first group or the second group.

For now, the only group I target is the first group, our freedom fighters. Yes, I disparage them as toothless chihuahuas but that can be turned around. There were tens of thousands of Canadians lining our highways as convoys, from the east and from the west, made their way to Ottawa. A call for donations in support of the convoy raised \$10 million in about a month. A second call raised a similar amount, again in about a month. I have seen and heard estimates, ranging from 5% to 30%, as to what percent of Canada’s population is “*awake*” and against this tyranny of T&T. Canada’s population is about 40 million people so 5% represents about two million people. I can readily argue there are millions more Canadians who supported the convoy in their hearts and minds. There is a real and significant part of the Canadian population that is against the tyranny of T&T, especially given the outrage over the depraved child sexual indoctrination policies and programs that now infest and pollute our children's education system.

But let’s play the devils advocate and ask what if these estimates are wrong with even two million being much too high? For better or worse we must know how many people in Canada (as wells as across the world) we can call upon to fight this war. If it turns how we only have a few ten’s of thousands of freedom fighters in Canada then we might as well throw in the towel because we simply do not have numbers to make a meaningful contribution to this war. Having said this, I am certain we have the numbers.
