#### 1 Introduction

- Toothless chihuahuas is a descriptor I began using in January of 2024 to mock and ridicule our fake freedom fighters here in Canada.<sup>1</sup> This report is about Wayne Peters at "What's Up Canada" and why he is a toothless chihuahua.
- This report on Peters is centred around one question:

We are in a global war.

# What is Peters doing to make a meaningful contribution to our fight in this global war?

- In my first three reports <sup>2</sup> about David Cheyne at Awake Canada, Rebecca Shephard at Stand4Thee and Amanda Ridding at Canadian Law Study Group, I explain in detail how they ignore the fundamentals of what we must do to win this global war. <sup>3</sup>
- Peters also ignores these fundamentals and the details are similar to those found in my reports about Cheyne, Shepherd and Ridding. I won't repeat the details in this report on Peters. In brief:
  - 1. Peters doesn't or can't identify the enemy that we must defeat to win this global war.
  - 2. Peters refuses to commit to the only course of action that can win this global war for us; unity with our large scale numbers.
  - 3. Peters works alone. He has no numbers <sup>4</sup>, no resources, no reach and no muscle.
  - 4. Peters has poorly defined objectives, strategies, metrics and results.
- What this means is there is little to nothing that Peters does that makes a meaningful contribution to our fight in this global war.
- "What's Up Canada" is a business and it's only purpose is to make money for Peters own personal use.
- Peters uses the pretense of "*freedom fighting*" to generate business for himself.
- Let's dig into the details.

# 2 Video and text reports

- This report on Peters is available as a video and as a PDF document, that is, the document you are reading now. Both video and document are accessible from the <u>"Reports" page on my</u> website.
- You will note that all paragraphs in this document are bulleted. That is because this document was used as a script to create the video report and it is easier for me to follow a script that is comprised of short and clearly delineated talking points.

#### 2.1 Video section times

- This document complements the video.
  - The table of contents in the document corresponds to the different sections in the video.
  - The time at which each section of this document occurs in the video can be found in the following table.
    - → For example, section 2 of this document is titled "*Video and text reports*". In the video, this section starts at time 00:01:51 that is, at the 1 minute and 51 second mark.
    - → Similarly, section 2.1 of this document is titled "*Video section times*". In the video, this section starts at time 00:02:16, that is, at the 2 minute and 16 second mark.

#### 3 Exercises

- When I first started reviewing what it is that Peters does, I immediately encountered a number of significant problems.
- Here are three conceptually simple exercises I want you to perform that illustrate a few of these problems.

#### 3.1 Exercise 1

- Books generally include a table of contents at the beginning which provide an overview of the topics covered in the book.
- On Peters Rumble channel, the video "*Do not watch this you will end up on a government watch list*" has four parts and is 15 hours long (see <u>part 1</u>, <u>part 2</u>, <u>part 3</u> and <u>part 4</u>). Without watching the four parts, what are the topics (i.e. similar to a table of contents) covered in each part?
- Take as much time as you want to perform this exercise. You can stop any time without completing it.

#### 3.2 Exercise 2

- Now I want you to watch the videos. Watch the first 10 to 15 minutes of parts 1, 2, 3 and 4, the same as in exercise #1. What does Peters say are the topics (similar to a table of contents in a book) covered in each part?
- Take as much time as you want to perform this exercise. You can stop any time without completing it.

#### 3.3 Exercise 3

- What is the title of the first video (i.e. the earliest) posted in Peters <u>Rumble channel</u>, <u>Substack channel</u> and <u>X/Twitter channel</u>? Is the title the same or different in these channels?
- Take as much time as you want to perform this exercise. You can stop any time without completing it.

#### 3.4 Answers

• In exercise 1, the video descriptions on Rumble tell us nothing about what Peters covers in his four part video.

- In exercise 2, you will again find each part does not have an introduction that explains what is covered. The only way to find out what the video is about and what topics are covered is to each part, from start to end.
- In exercise 3, what you will find is the title of the very first/earliest video is different in each social media channel. In addition, Rumble is the only channel where this exercise is easily performed by every person.
  - O Let's walk through this exercise.
  - On the Rumble channel, simply select the last page, scroll to bottom of the last page and we see the title of the first video is "Challenge Issued, The Ball is Now In Premier Ford's Court".
  - As explained in section 8 of this report, Peters tries to use his Substack channel to provide some organization to the videos on his Rumble channel. However, Substack's scrolling user interface makes this part of exercise 3 a tedious, time consuming and error prone process such that most people will give up without finding the answer.
  - On the X/Twitter channel, the scrolling user interface also makes this part of exercise 3 a tedious and time consuming process and the few who attempt this exercise will be not motivated to complete it.
- The point of these three exercises is:
  - 1. To show there is little organization to Peter's videos.
  - 2. To show the only reliable way to know what is covered in a video is to watch it from start to end.
  - 3. To show the sheer volume of videos Peters creates, with the understanding the sheer volume means few people will watch them.
  - 4. To show Peters should not be using Substack to try organizing videos on his Rumble channel.
- The lack of organization and sheer volume of videos is our first big clue Peters is not trying to make a meaningful contribution to our fight in this global war.<sup>5</sup>

#### 4 Overview

- I first learned about Peters after watching The Lavigne Show titled <u>"Peaceful Dethronment"</u> around mid December of 2024.
- Peters was reasonably well spoken and, as is typical of many of our toothless chihuahuas, made a favorable first impression.
- In early 2025, for a short period of time, I was part of a small group that met online once a
  week.
- At my request, Peters was invited to join the group, which he did.
- I had a few exchanges with Peters. We did not agree with each other.
- In early September, I decided to spend some time looking into what it is that Peters does, hence the reason for this report.
- Peters website is What's Up Canada.
  - O His social media channels are on <u>Rumble</u>, <u>Instagram</u>, <u>Librti</u>, <u>Substack</u>, <u>Telegram</u> and <u>X (i.e. Twitter)</u>.
  - O Peters hosts a live stream show most days of the week. He records and posts these videos <sup>6</sup> on his Rumble channel.
  - O Peters uses his Substack channel as a prop to provide the illusion of organization for his Rumble videos.
  - Peters X/Twitter channel is an unmanageable rat's nest where his posts are soon lost and forgotten.
  - O Peters Telegram channel has relatively little activity.
  - O Peters has few followers on Instagram and Librti.
  - In effect, the Rumble channel is primarily where all the action is happening for Peters. So this report will be focused exclusively on content from Peters Rumble channel.
- When I first began preparing for this report in early September, Peters had more than 500 videos. As a general statement, they can be classified in one of three groups:
  - Group #1: Each video consists of or contains a series of video clips and screen captures from/by other people (e.g. <u>Treason Season Hamas Wins</u>, <u>Freeland Bolts Soros Meets RICO?</u>). These videos are generally two hours and longer.

- Group #2: Peters talks one-on-one with one or more people (e.g. "Bankers Bandits Bullion and Buck\$ With Bryce" episodes). These videos are generally about one hour long.
- Group #3: These are videos for Freedom Train International (e.g. Freedom Train Int: <u>Climate Lockdown - Canada on Fire</u>). They are generally about four hours long, each typically being broken into four one-hour segments, with a different set of people speaking in each segment. It is in one of these one-hour segments that Peters chats with one or more people.
- The majority of Peters videos fall into Group #1.
- Table 2 lists the number of videos in each year and the number of views per video.

- The values in Table 2 were generated starting with the video "<u>Treason Season Hamas Wins</u>" dated September 22, 2025 and working backward to January 1, 2022. 9
  - The number of videos in each year from 2022 to 2025 are 64, 97, 143 and 246, respectively. Note the number of videos increases each year.
  - O The average number of views per video from 2022 to 2025 are 6.78K, 4.88K, 3.57K and 3.42K, respectively. Note the average decreases each year.

- O The median number of views per video from 2022 to 2025 are 2.54K, 2.08K, 2.84K and 2.98K respectively. Note the median values are relatively constant.
- The average view count for each video in 2025 is only 3.42K. So the video "*Freedom Train International NYE Event*" with 58.5K views that is featured on the first page of Peters Rumble channel is the exception and not the rule.
- From Table 2 we can see that:
  - 1. Relatively few people watch Peters videos.
  - 2. The more videos he makes, the fewer people watch them.
- These are two more clues that Peters does not not make a meaningful contribution to our fight in this global war.

## 5 Objective?

- An assessment of what Peters is doing requires we have a clear understanding of what his objective is with What's Up Canada?
- So what exactly is Peters objective, what is his end goal, what is he trying to accomplish?
- The answer is Peters doesn't tell us, on his website or on his social media channels.
  - The bottom of Peters Substack ABOUT page reads "Independent Canadian Journalist".
  - The description in Peters Telegram channel reads "Politically Unreliable Journalist...".
  - The description in Peters X/Twitter channel reads "Gathering community as we adapt, improvise, and overcome the obscene censorship of an infiltrated nation undergoing a hostile corporate coup."
- Looking elsewhere, Peters has stated:
  - "I'm just an average guy that has a few skills and wants to make shit make sense for the people that I love in the country that I love. It's really that simple."  $^{10}$
- Peters states he is all about the "*truth*", and in particular, about providing "*clarity*". For example:
  - O He claims his platform "was one of the biggest seeds of **truth** available anywhere in the world and that I think was ultimately why they silenced us." <sup>11</sup>
  - O Peters stated, "So, if we're going to move forward and be a part of the fight, the more **clarity** that we have, the more power we have. Right. You guys have heard me say that an awful lot lately. **Clarity** is power." <sup>12</sup>
- Is Peters trying to be a journalist, is he trying to build a "*community of clarity*" <sup>13</sup> or is he really just trying "to make shit make sense"?
- The answer is none of the above.
- Like an illusionist who distracts our attention away from his trick, Peters distracts our attention away from the trick he plays on us.
- Peters distracts our attention masquerading as a "*freedom fighter*" while hiding right in front of us that he is in business to make money for himself.

- Peters has two business side ventures while the "*What's Up Canada*" platform itself is Peters main business venture.
- The "What's Up Canada" platform is where Peters want to be a full time social media influencer focused on increasing ratings and making money.
- But few pay Peters any attention, his ratings are very low and he has thought about giving it up.
- So the answer to question of what is Peters doing to make a meaningful contribution to our fight in this global war becomes very clear?
- The answer is he is not making, and never intended, to make a meaningful contribution.
- Peters is in business to make money for himself under the false pretense of being a freedom fighter.

#### 6 Partners

- When I first looked at Peters website, one of the curious things I noticed is it lists "partners" instead of "allies". There are two partners, the first is "Precious Metals" and the second is "Switch With Wayne".
- It turns out both are business partners, they are about making money but not freedom fighting.
- Now I have no objections to Peters making money.
- But I do object to Peters hiding behind the pretense of being a freedom fighter to make that money.
- Let's take a look at Peters partners.

#### 6.1 Precious metals

- Most people are only featured once or twice in Peters videos.
- Not so for Bryce Wade.
- As I write this report section, there are 66 episodes of "Bankers, Bandits, Bullion and Buck\$ with Bryce"
- That represents over 10% of the videos on Peters Rumble channel.
- I watched three episodes, those being 46, 61 and 66.
- In these episodes, Peters did not disclose if he makes money promoting Wade and precious metals.
- However, given the almost weekly air time Peters gives Wade, it is reasonable to assume this is a business relationship which makes money for both of them.
- The three episodes I watched feature a standard *bait-and-hook* sales ploy.
  - The bait is to hype the many serious problems we face in this global war.
  - The hook is to hype the solution, which is to buy precious metals to hedge and protect against these problems.
- But there are a few wee hiccups that Peters and Wade conveniently ignore or forget to mention.
  - 1. Why do Peters and Wade constantly talk about problems, problems and more problems but never solutions, that is, other than the one that puts money in their pockets, which is to buy precious metals?

- 2. If a new world order of One World Government is successfully established and you are trying to live off-grid then, when your power generator fails and you need replacement parts, how are you going to buy those parts with clippings from your gold necklace when the parts supplier only transacts in CBDCs that, incidentally, require a digital identity and an approved social credit score, none of which you have?
- 3. If a new world order of One World Government is successfully established then it will not tolerate competition and your tiny trusted community and parallel economy will be crushed.
- 4. Given Peters and Wade appear to be aware of the real and dire existential crisis we face today, why do they never talk about unity with our large scale numbers, you know, literally the only solution that will win this global war for us?
- So you see, buying precious metals today, to hedge against tomorrow's One World Government, turns outs not to be such a good hedge after all.
- All Peters and Wade are doing is trying to make money today, they don't really care about what happens tomorrow.
- Peters claims to be about truth and clarity but here is some truth and clarity you will never get from him:
  - The only way we little people can win this global war is for us to eliminate the cabal and it's global network.
  - The only way we can eliminate the cabal is if we unite across Canada and across the world.
  - O In the three episodes I watched, Peters and Wade say nothing about eliminating the Cabal and nothing about uniting us.
  - To be fair, Wade makes no claim to being a freedom fighter. Wade is a business man and his only focus is promoting his business today.
  - On the other hand, Peters claims to be fighting to save Canada <sup>15</sup> and that his job is to bring truth and clarity to our fight. 16
  - Based on the three episodes I watched plus the extensive air time Peters gives Wade, what I conclude is these episodes are all about, and only about, making money for Peters and Wade.

- Now I'm sure it is just a coincidence I watched the only three episodes where Peters and Wade get caught up in problems, problems and more problems and forgot to think about solutions that benefit all of us.
- Unfortunately for Peters, I wasn't prepared to spend another 30 to 40 hours going through more episodes of Peters & Wade.
- As such, I believe and conclude Peters is hiding behind the pretense of being a freedom fighter to make money for himself.
- So how do the episodes of "*Bankers*, *Bandits*, *Bullion and Buck\$ with Bryce*" contribute to our fight in winning this global war? The answer is, they don't and they aren't intended to.

#### 6.2 Switch with Wayne

- Let's take a look at Peters second sideline business.
- Clicking on "Switch With Wayne" redirects us to <u>Peters other website</u>.
  - O Gosh, golly, darn, but I can't find anything about "freedom fighting" on Peters 2<sup>nd</sup> website.
  - O You see, Peters is selling products from/for the American company Melaleuca.
  - O It's business model uses an Amway like pyramid sales structure where Peters has a sponsor who takes a percent of what he sells and Peters takes a percent from people he sponsors.
- Let's be very clear here.
  - O Peters promotes his business at the beginning and at the end of every single one of his videos.
  - O Peters pitches "Switch With Wayne" as an army of freedom fighters. 17
  - O Peters pitches that when you buy from him, you become a patriot in his freedom army, fighting the good fight, engaged in dollar warfare against the deep state. <sup>18</sup>
  - And that's the trick illusion Peters is trying to deceive us with.
- "Switch With Wayne" is not about freedom fighting.
  - O It's about making Peters money in the here and now.
  - O This is a toothless chihuahua's brazen example of grifting and fraud.

I watched "A 'Must Watch Film' - The Agenda" expecting Peters to offer his understanding, insights and critical review of this documentary by Oracle Film.

I watched "Blackrock? What about them.", looking for proof that Peters understand the fundamentals of what we must do to fight and win this global war of Technocracy and Transhumanism.

I watched "Do not watch this you will end up on a government watch list" because this was a four part video, suggesting to me that whatever the subject matter was, it was extensive and compelling.

I watched "*Being Hated for Truth*" because of it's title. The title suggested Peters is being hated for telling the truth and I wanted to understand the details of why.

I watched "Saying the quiet parts out loud" because of it's title. Again, I was looking for proof that Peters understand the fundamentals of what we must do to fight and win this global war of Technocracy and Transhumanism.

I watched "*The end of the new world order*" because of the absurdity of this title. I wanted to see what evidence Peters had in support of the notion we are seeing the end of the new world order.

I randomly watched three episodes of "Bankers, bandits, bullion and buck with bryce" to get an idea of what they are about.

The remaining videos I watched were selected because of their titles.


All videos I watched are recent or relatively recent with the expectation they would give me some idea of what Peters is currently thinking, about as opposed to what he might have thought several years ago.

## 8 Little organization

- If you want to discourage people from watching your own videos then, by way of example, Peters shows you how to do this.
- As mentioned, when I started preparing for this report in early September, Peters had over 500 videos on his Rumble channel.
- In the first 9 months of 2025 (i.e. a total of 39 weeks), Peters produced 246 videos, or an average of 6.3 videos per week. The majority of them are 2 hours or longer.
- In the videos I watched, there is very little organization:
  - O Titles generally do not reflect actual subject matters/contents.
  - As illustrated in the next figure, video descriptions contain no information about subject matters/contents and this appears to be the case for all Peters videos on his Rumble channel.

- In the 23 videos I watched, the only way to know what the subject contents/matters are covered is to watch the entire video, from start to end.
- In the Rumble description for each video, Peters states general information (i.e. details, links and resources) can be found on his Substack channel. That is only partially true.
  - O For July to September, Peters has 66 videos on his Rumble channel <sup>20</sup> but only 34 entries on his Substack channel.
  - O For October, Peters has 21 Rumble videos <sup>21</sup> but only 15 Substack entries.
  - O For November 1 to 17, Peters has 11 Rumble <sup>22</sup> videos but only 9 Substack entries.
  - O So there are a total of 98 Rumble videos from September 1 to November 17 but only 58 Substack entries.
- There is also a navigational problem with Substack which significantly impacts Peters.
  - The Substack scrolling user interface, which is all a majority of people will know and use, is not designed to handle more than a few pages of posts/entries.
  - O Trying to use this scrolling user interface to access more than a few pages is a time consuming, tedious and error prone process. <sup>23</sup>
  - Peters Substack channel has 345 posts/entries <sup>24</sup>, most of which are inaccessible to the majority of visitors specifically because they are casual users that are not proficient in Substack and who only know how to work with the scrolling user interface.
- Effectively, Peters Substack channel provides the illusion of organizing his Rumble videos, but for practical purposes, it is non-functional.
- This does not make any sense for a supposed freedom fighter who is trying to make a meaningful contribution to our fight in this global war.
- But it does make sense for an internet entertainer who only has to provide the appearance of organization without actually have to be commit to the real and serious work of organizing.
- It's all about showbiz and entertainment.

#### 9 The fundamentals

• This entire report is centred around one question:

# What is Peters doing to make a meaningful contribution to our fight in this global war?

- Here are 5 questions that address the fundamentals of what we must do to fight and win this global war:
  - 1. Who is the enemy we must defeat to win this war?
  - 2. What is our primary objective in this war?
  - 3. What is our primary strategy to win this war?
  - 4. What type of leadership do we need to win this war?
  - 5. What resources do we need to win this war?
- Peters doesn't answer these questions in any of his videos that I've watched.
- For question 1, Peters has provided different responses at different times:
  - Early this year, Peters was part of small group where I asked these 5 questions. At that time, Peters identified our enemy as the British Monarchy.
  - O In his videos that I watched, there are a very few occasions when Peters seems to be suggesting the "*Cabal*" is our the enemy. But they are little more than blurbs and are certainly not a compelling indictment of the Cabal by Peters. <sup>25</sup>
  - O In the videos "Do not watch this you will end up on a government watch list" and "Treason Season Hamas Wins", Peters says Muslims and Islam are our enemy.
  - The point is that Peters doesn't know who the enemy is that we must defeat to win this global war.
- Again, the 5 questions above are about the fundamentals of what we must do to fight and win this global war.
- If Peters is a true freedom fighter then these questions and their answers are something that he is expected to make clear in EVERYTHING he does.

- And yet Peters doesn't. He doesn't even ask these questions, let alone answer them even after I brought these questions to his attention early this year.
- The only way we can win this war is if we unite, across Canada and the world. Peters knows this. In the videos I watched, Peters never talks about is our unity or uniting us. <sup>26</sup>
- How can Peters make a meaningful contribution to our fight in this global war if he can't even get the fundamentals right?
- The answer is, he doesn't and never intended to.

# 10 Problem, symptom, cause

- Peters is only focused on symptoms but never cause.
- And the big question is why?
- Let me explain.
- A problem has a symptom(s) and a cause(s).
  - To resolve a problem requires focusing on and eliminating the CAUSE.
  - Focusing only on the SYMPTOM perpetuates the problem.
- Here's an example.
  - O Consider the problem of a wet floor with water dripping from the ceiling because a joint in the pipe above the ceiling is leaking.
  - The CAUSE of the problem is a leaking pipe joint and the SYMPTOMS of the problem are water dripping from the ceiling and a wet floor.
  - O Using this analogy, Peters is focused only on water dripping from the ceiling and a wet floor (i.e. the SYMPTOMS) while completely ignoring the leaking pipe (i.e. the CAUSE).
- As another example, people suffer from disease.
  - O There is the cause(s) of a disease and there is the symptom(s) of a disease.
  - O Solving or curing a disease requires eliminating or removing the cause(s).
  - Treating only the symptom(s) perpetuates the disease.
  - O For example, when a person had a cold then a runny nose, a sore throat and loss of taste are all symptoms of the cold but they are not the cause of the cold. The person's health was severely run down and the person was already sick BEFORE the symptoms appeared.
  - O Using this disease analogy, Peters constantly talks about a runny nose, a sore throat and loss of taste (i.e. the SYMPTOMS) while completely ignoring the person is very run down and in poor health (i.e. the CAUSE).
- We are in a global war.
  - For us, this war is a problem. Like all problems, this war has symptoms and a cause.
  - O Examples of the SYMPTOMS of this war are 15 minute cites, bug food, digital currency, digital identity, lawfare, SOGI, UNDRIP, unsafe & ineffective "vaccines", a migrant crisis, etc.

## 11 The begging parrot

- What makes a majority of Peters shows unique and original is that they are not unique and original.
- Peters does not have the luxury of time to be unique and original because he is churning out a video most days of the week, the majority being 2 to 4 hours of audio-visual diarrhea that few people watch.
- In his noble and unrelenting quest to make quality come a distant second place to quantity, Peters has hit upon a magic formula.
- Peters is a parrot, someone who habitually copies the work of other people.
- And Peters is not just any parrot. Peters is special breed of parrot, his trademark signature being he is a parrot parroting parrots.
- Let me illustrate.
- Lyle Culpepper is someone who created his own video.
- Tal Oran is a person who <u>created a video</u> showing Culpepper's video.
- In turn, Peters created a video showing Oran's video showing Culpepper's video.




Figure 2: Peters video showing Oran's video showing Culpepper's video

- This is illustrated in Figure 2 where we can see Oran in the top right corner (he is partially masked by Peters What's Up Canada logo) and Peters on the left side.

- What we have is Peters parroting (i.e. copying) Oran and Oran parroting (i.e. copying)
   Culpepper.
- In other words, Peters is a parrot parroting a parrot and we see this pattern in lot of Peters videos.
- By the way, this is an amusing sleazebag video by Culpepper and I review it in section 16.2 of this report.
- Anyways, as I mentioned earlier in the Overview section, the majority of Peters videos fall into Group #1, which is where Peters showcases his lack of talent by being parrot.
- What makes all this so entertaining is Peters is constantly begging for donations and financial support for a variation of plagiarism.
- Imagine that! Peters expects to be paid for habitually copying the work of other people.
- I simply can't understand why Peters ratings are so low and his donations are not pouring in.

## 12 Low ratings

- Table 2 in the "*Overview*" of this report shows Peters ratings <sup>27</sup> are decreasing even as he churns out more and more videos.
- Few people watch Peters live shows and his videos.
- Ratings are low, especially considering Peters has acquired a bit of an international audience through his work with Freedom Train International.
- Yes, we face global censorship. But there are more plausible explanations for why Peters ratings are so low.
  - Explanation #1: The first and obvious explanation is Peters is competing, quite poorly, against thousands of videos, blog posts, articles, etc. that our toothless chihuahuas churn out each month.
  - Explanation #2: For the most part, Peters doesn't tell us anything we have not already heard, seen and/or know. Most of us already have our own trusted sources that offer far greater balance, credibility and integrity than what Peters serves up.
  - Explanation #3: Peters videos are too many, too long, too disjoint, to biased and of low informational value. They constitute what I refer to as audio-visual diarrhea; the shit keeps running and never stops.
- This does not make sense for a freedom fighter who wants to win this global war. But it does make sense to someone who is into showbiz and entertainment.
- Let's look at a few of Peters videos to illustrate these points.

### 13 Video reviews

The 6 videos I review from Peters Rumble channel are:

- 1. "Being Hated for Truth" (2025-09-03)
- 2. "A 'Must Watch Film' The Agenda" (2025-06-05)
- 3. "Do not watch this you will end up on a government watch list" (2025-08-18 to 2025-08-26)
- 4. "Saying the quiet parts out loud" (2025-8-26 to 2025-8-27)
- 5. "Blackrock? What about them." (2025-07-11)
- 6. "The end of the new world order" (2025-08-29)

Video #3 has four parts, video #4 has two parts, for a total of 6 parts. As such, my review includes a total of 10 separate videos from Peters Rumble channel. I found these 10 videos to be representative of the other 13 videos I watched but do not review in this report.

### 13.1 Video review – Being hated for truth

- This was an easy video to review.
- It was published on September 3 and is about 1.5 hours long.
- The title suggests that Peters is being hated for telling the truth.
- The video title is click bait.
- Peters provides no information or evidence to support his claim.
- Appendix C lists the different segments I identified in this video and the time at which each segment starts.
- The background context to this video is as follows.
  - O Peters took a short trip to the US.
  - O During his trip, Peters made a recording of himself where he is publicly/openly sharing a message meant for Pierre Poilievre, leader of the federal conservative party. <sup>29</sup>
- In <u>the description of this video</u> on Peters Substack channel, he claims the "backlash" he received for his open message to Poilievre ranged from "spinning support" to "rage and vitriol".
- This is false, there was no backlash.
- This video by Peters is 98 minutes long. The first 48 minutes <sup>30</sup> and last 37 minutes <sup>31</sup> have nothing to do with Peters supposedly being hated; that's 85 of 98 minutes being unrelated to the supposed subject matter in the video title.
- Of the remaining 13 minutes, only 00:02:50 minutes <sup>32</sup> appears to be about "*spinning support*" and "*rage/vitriol*".
- So, let's take a look at the evidence Peters provides.
- Peters refers to a comment from a person identified as Voltaire. <sup>33</sup>
  - O Voltaire's full comment is listed in Appendix D.
  - There is nothing in Voltaire's comment that constitutes "*spinning support*" and "*rage/vitriol*".

- Next, Peters shows two comments from someone identified as "Spades".
  - Appendix C shows the comments posted by Spades at time 01:07:02 and 01:09:19.
  - O In the first comment, Spades starts off with "STFU", an acronym for "shut the fuck up". 34
  - O Spades wrote in the 2<sup>nd</sup> comment, "You have either fallen in with the petulant child called Maxime Bernier and his PPC who all deliberately spread lies about Pierre or you are not listening to what Pierre is saying."
  - O In the second comment, Spades ends with "FO", an acronym for "fuck off". 35
  - O I believe what Peters is calling "spinning support" is the part "You have either fallen in with the petulant child called Maxime Bernier...".
  - O Yes, Spades swears at Peters.
  - O But "rage and vitriol" are two extremely strong emotions and Spades doesn't express either.
  - O Is there any more evidence Peters shows us? The answer is no, that's it.
- At the time I wrote this report, there were 139 comments to Peters X/Twitter post. <sup>36</sup>
- I did not find any other comments which could be construed as "spinning support" or "backlash, rage and vitriol".
- In other words, Peters has made a mountain out of a mole hill.
  - O To say Peters is grossly exaggerating is an understatement.
  - Ok, Peters is making shit up.
- So what is Peters up to?

- Consider the following statements by Peters in this video:
  - 1. "I don't believe that there is a political solution. There is not going to be a political solution until the discussion is a 1776 <sup>37</sup> level of change, hopefully without the violence."
  - 2. "I want to send a message out to Mr. Poilievre...Mr. Poilievre you are not giving Canadians what they what they want. And unfortunately Mr. Poilievre they're not going to vote for you because you're not giving them what they want." <sup>39</sup>
  - 3. "...anybody that gets their seats (in Canada's Parliament) is going to continue to fail because that is the way the system is built...at the end of the day it doesn't change where we're at right now....The (political) system is death. The entire (political) system is the death of our country..." <sup>40</sup>
  - Peters is saying, quite clearly, that there are no political solutions in Canada to the many problems we face and that our political system will not change.
  - O Peters knows Poilievre is a puppet and follows orders from his handlers.
  - O Peters has no numbers, no resources, no reach and no muscle.
  - O Here is the point. Peters knows his open message to Poilievre is unlikely to even reach the conservative party and it's top members. But even if Peters message did reach them then his message will fall on deaf ears.
  - O The question then is, who is the audience that Peters is targeting with his open message to Poilievre? The answer is Peters followers.
- The video title is click bait and Peters false claim of being "hated for telling the truth" is a dodgy way of trying to sensationalize himself and entertain his few followers.
- This is all about showbiz and entertainment.

### 13.2 Video review – A must watch file – The Agenda

- Oracle Films produced the documentary "*The Agenda: Their Vision Your Future*".
- I had already had watched this documentary before watching Peters video.
- So when I saw Peters video title "A 'Must Watch Film' The Agenda", what I was expecting was for Peters to offer his understanding and insights into the documentary and/or the Cabal's agenda.
- I mean, no one would brazenly parrot an entire documentary made by somebody else when it would simply suffice to provide a link to the documentary and encourage us to watch it, right!
- So you can imagine how I hard I laughed when I realized that was exactly what Peters had done.
- He parrots the entire Oracle documentary.
- I would be ashamed and embarrassed to copy the entire work of someone else.
- After parroting the documentary, Peters video then continues for about another 30 minutes.
- What's in these last 30 minutes? I don't know and I don't care.
- But whatever it is, that is all that should have been in Peters video in the first place.
- I didn't watch the last 30 minutes because there was nothing, absolutely nothing, Peters could say that would redeem himself.
- So what happened here?
- Peters has a time slot to fill and nothing of his own to fill it with.
- But he has to show something and so he parrots the entire documentary and hopes his few followers are not paying attention.
- No one ever said showbiz and entertainment makes for an honest day's work.
- And no Peters, don't even try to argue you are promoting the documentary.

# 13.3 Video review – Do not watch this you will end up on a government watch list

- This is a 4 part video, about 15 hours long and that was published between August 18 and August 21.
- 15 fucking hours!!!
- If I'm going to watch a 15 hour video then what I expect is a description and an introduction that clearly and concisely explains the purpose of the video plus a clear description of the video contents, how the contents are organized and why they are organized that way.
  - O I want to learn something from the video.
  - O I don't want to constantly struggle trying to make sense of it.
  - O But staying true to form, Peters video is poorly organized and trying to make sense of it is a constant struggle.
- The video title and description on Rumble give us no clue of the subject matter.
- After the opening theme song, Peters rambles for about 9 minutes and it is only at 00:10:38 that he finally tells us the subject matter is "*Islamophobia*" and he is doing a "*deep dive*".
- Except it isn't and he doesn't. This video is not about an irrational fear of Islam and it isn't a deep dive!
- All Peters offers is a superficial, repetitive, biased and limited perspective of our migrant crisis in western countries that amounts to little more than tabloid reporting.
- As in the majority of Peters videos, Peters is a parrot parroting video clips made by other people.
- Peters doesn't know know how to be concise and to the point, nor does he want to.
- If Peters removed everything he parrots, leaving only his own original commentary, assessments and/or opinions which is what Peters should be doing in the first place then this 15 hour video could have been reduced to 30 minutes or less, making it concise, effective and meaningful.
- But Peters is not interested in being concise, effective and meaningful.
- That's now how showbiz and entertain work.

## **13.3.1** Purpose?

• Here's a question for you. What is the purpose of this video, why did Peters make it?

- The answer is we don't know, Peters doesn't tell us and we are left to speculate.
  - O Does Peters think he is really telling us something original and unique, something we don't already know? The answer is, unlikely.

  - O Is Peters saying his message is that Islam is not a religion of peace and hoping this will trigger Canadians into action to fight against our migrant crisis? The answer is, unlikely.
  - O Is Peters venting his frustration while he helplessly watches his Christian world collapse around him? The answer is, there is some truth to this, so yes, there is a possibility that this is the video's purpose.
  - O Is Peters a wannabe social media influencer, trying to make this his full time job and, in doing so, is just trying protect his livelihood as well as retain his small and shrinking viewer base with self aggrandizing, shock jock value, tabloid-like sensationalism? The answer is, quite likely.

### 13.3.2 Our migrant crisis

- We've known for quite some time that western countries have been and continue to be flooded with non-white migrants, many from Muslim/Islamic countries.
- This is a real existential crisis that threatens our western values, cultures, traditions and white populations.
- Why is Peters only addressing this crisis now and, besides wasting time talking about it and begging for donations, what is he actually doing about it? The answer is nothing.
- Here are a few basic questions I have for Peters:
  - 1. Why is it happening, what is the cause of our migrant crisis?
  - 2. What, if any, are viable solution(s) to our migrant crisis?
  - 3. What are we doing to organize and mobilize Canadians to counter and solve our migrant crisis in Canada?
  - 4. A solution to our migrant crisis in Canada necessarily requires we coordinate our efforts on an international basis with other western countries. What are we doing to coordinate our efforts on an international basis?
  - 5. If Muslims and Islam are a bad as Peters claims they are then why are all western countries allied with a majority of Muslim and Islamic countries in the world?

- These are but a few of the basic questions that should be addressed by anyone who claims be to doing a "*deep dive*" into our migrant crisis.
- What we need are answers, solutions and action, we need to organize and mobilize millions of Canadians to solve our migrant crisis.
- In this four part, 15 hour video, Peters repeats over and over and over again, "Hey guys and gals, we have a migrant crisis".
- Peters, we already know that.
- What we don't need is another Chatty-Cathy windbag like you that pours gasoline onto a fire for personal gain.
- This video is an example of what I refer to as audio-visual diarrhea, the shit keeps coming and doesn't stop.
- Let's take a look at three of many issues with this video.

### 13.3.3 Issue #1 – no organization

- Appendix E lists the general segments in the video that I have identified.
- For this video, Peters has collected over 50 different video clips plus screen captures.
- The problem is that Peters doesn't know how to organize and present his material in a meaningful way.
- If there is any logic to the sequence in which Peters shows us his treasure trove then I don't see it and Peters doesn't tell us.
- It appears Peters has simply presented his material in random order.
- That might be acceptable for a 15 minute video but is it not acceptable for a 15 hour video.
- We already know we have a migrant crisis.
- Peters obsessive compulsive need to demonstrate this in one video clip after another, without any meaningful sequence, is like listening to a broken record.

#### 13.3.4 Issue #2 – biased and one-sided

- This video is Peters version of propaganda.
- In 15 hours of video, Peters parrots material that is heavily biased, one sided Islam-is-the-problem, pro-American and pro-Israel propaganda.
- Let me use an analogy.

- Our western migrant crisis is like a raging fire.
- O Peters goal is not to extinguish that fire.
- O Peters goal is to pour gasoline onto it. 41
- O Peters needs attention and he hopes stoking this fire will give him that attention.
- There is no balance in Peters coverage of our migrant crisis.
- Peters conspicuously ignores Western geopolitical interference and domination in and over Muslim/Islamic countries.
  - Here are some specific examples that I expect would be covered to provide the context or background to a deep dive on our migrant crisis:
  - O There is no mention that Saddam Hussein and Iraq were used as a western geopolitical proxy puppet to fight a war against Iran.
  - There is no mention of the false and fraudulent claims of weapons of mass destruction to justify an illegal western invasion, war and occupation of Iraq, as well as an illegal invasion and occupation of Afghanistan.

  - There is no mention that Israel repeatedly sabotaged peace efforts with the Palestinians.
  - O There is no mention of the decades of terrorism by Israel against Palestinians.

- O There is no mention of the Yinon Plan <sup>43</sup>, the expansion of Israels borders which guarantees endless conflict, war and ethnic hatred in the middle east.
- There is no mention of the flagrant and horrific slaughter, ethnic cleansing and genocide of the Palestinians by Israel over the past two years, that is, other to ignore it's happening.
- O In one breath, Peters states, "This Palestinian crap is death cult ideology....How do you stop a death cult ideology? You have to destroy it." <sup>44</sup> and in the next breath he pretentiously claims <sup>45</sup> "I'm not on either side." <sup>46</sup>
- Yes, Peters rages against the Muslim and Islam crisis in our western countries.
  - O But we also have a Jewish Zionist crisis in all western countries that is on par with and has existed long before our Islam migrant crisis.
  - O Peters hints at this crisis once.<sup>47</sup> But other than this one instance, it is conspicuous in the videos I watched that all we hear from Peters are crickets.
- With the exception of a short 12 minute clip about "how the modern Middle East was carved from betrayal, deception, and colonial ambition" <sup>48</sup>, Peters demonstrates no effort to provide an unbiased, objective and balanced coverage on the supposed subject matter of "Islamophobia".
- Yes indeed, according to Peters superficial narrative, our fight is only against Muslims and Islam.
- Very simply, Peters has cherry picked his material to pour gasoline onto an already raging fire.

### 13.3.5 Issue #3 – symptom but never cause

- As I have discussed in section 10, a problem has a symptom(s) and a cause(s).
  - O Focusing only on the symptom does not solve the problem.
  - O Solving the problem requires identifying and eliminating the cause.
- Let's be very clear here.
  - O We are in a global war and this war is our #1 problem.
  - The cause of this problem is the Cabal and it's global network.
  - The Cabal has engineered our migrant crisis.

- Our migrant crisis is a symptom of this global war.
- Our migrant crisis is but one of many, many symptoms in this global war.
- O In 15 hours of video, Peters is focused solely on this one particular symptom of this war but never the cause of this war.
- In this video, Peters equates our migrant crisis with an invasion by Muslims and Islam.
  - O Peters acknowledges people from India constitute a big part of our migrant crisis.
  - O Unskilled migrants from Africa and many other 3<sup>rd</sup> world countries also constitute a big part of our migrant crisis.
  - O Nevertheless, Peters is focused almost exclusively on Muslims and Islam, that must be said, are not from India and other 3<sup>rd</sup> world countries.

#### Now then...

- O Muslims and Islam did not forcibly impose the global fraudulent covid mandates on us.
- O Muslims and Islam did not forcibly impose on us, across the world, the clot/kill shots euphemistically referred to as "*vaccines*".
- O Muslims and Islam are not the global force behind digital currency, digital identity and social credit scores.
- Muslims and Islam are not the global force that are waging this global war of Technocracy and Transhumanism against us, marching us towards a new world order of One World Government.

## 13.4 Video review – Saying the quiet parts out loud

- This two part video is about 6 hours long, with parts 1 and 2 published this year on August 26 and August 27, respectively.
- What are the quiet parts Peters wants to say out loud? The answer is there aren't any.
  - O Peters simply found an X/Twitter post by someone identified as Ryan C that started with "... *Poland's Ambassador to Canada says the quiet part out loud.*..". <sup>49</sup>
  - Peters thought that would make for a clever and catchy title and so, being true to form,
     Peters parroted the phrase.
- Here's a 2<sup>rd</sup> question.
  - O The following clips are included in this video: 1) Sheila Gunn whining that anti-semistism is not getting any attention from the RCMP <sup>50</sup>, 2) Wyatt Claypool talking about the border problem of drugs and international crime <sup>51</sup>, 3) a jewellery store robbery in North York <sup>52</sup> and 4) James O'Keefe goes hiking in Nova Scotia <sup>53</sup>?
  - The question is, what exactly do they have in common to justify including them in the same video?
  - O The answer we don't know and Peters doesn't tell us.
- This leads to the 3<sup>nd</sup> question.
  - O What is the objective or point of this video?
  - O The answer is we don't know and Peters doesn't tell us.
  - O It appears Peters simply had a large collection of video clips left over from his recent video titled "*Do not watch this you will end up on a government watch list*" and figured he could fill up two more daily slots with the left overs.
- Appendix F lists the different segments I identified in this video.

- What I found is a little under three hours is about our migrant crisis as related to Indians from India <sup>54</sup>, a little under two hours has nothing to do with our migrant crisis <sup>55</sup> and only a little under one hour is about Muslims and Islam <sup>56</sup>.
- This video is a continuation of, and suffers from the same problems as, the video "Do not watch this you will end up on a government watch list".
- There is no meaningful sequence to the video clips Peter shows, they are presented in a random order.
- Peters simply doesn't know how to organize his treasure trove of fools gold.
- Between the video "Do not watch this you will end up on a government watch list" and this video "Saying the guiet parts out loud", Peters serves up 21 hours of repetitive and redundant audio-video diarrhea that tells us what we already know, we have a migrant crisis. Whoop-deefucking-doo!
- When I first started watching part 1 of this video, at about the 30 minute mark, I realized this was going to be another mind numbing session where Peters is again just a parrot parroting other people.
- At that point, I literally pulled my headphones off in exasperation and walked away from my computer.
- Let me say the quiet part out loud. Watching this video was a complete waste of my time.
- Why is it so impossible for Peters to think for himself and to offer only his own original commentary, input and analysis? That's another rhetorical question.

#### 13.5 Video review – Blackrock? What about them

- This is where I first began to understand Peters real objective is to make a business of his "What's Up Canada" platform as a social media influencer.
- The title of this video is another piece of click bait.
- There are a few blurbs about Blackrock but Blackrock is not the subject topic of this video.
- In what I now recognize as classic Peters, he parrots an entire <u>Julian Dorey interview of Ian</u> Carroll. <sup>57</sup>
- Peters interjects 7 times with his own comments and the total time spanned by these 7 comments is a little over 13 minutes:
  - 1) At 00:17:42 (1m, 0s), Peters argues his low ratings (e.g. 67 on Facebook) is proof of social media lock downs.
  - 2) At 00:29:31 (0m, 25s), Peters goes off topic and says Bryce Wade's predictions for precious metals came true.
  - 3) At 00:39:45 (1 min, 45s), Peters says Blackrock, Vanguard and State Street control our futures because they are the investment managers for many of Canada' pension plans such as the Ontario Teachers Association. This is hardly an explanation of what Blackrock's strategy is to control the future.
  - 4) At 00:43:47 (0m, 16s), Peters says he believes the US government is a 50% stakeholder in Moderna. So what? What is Peters point? He leaves that for us to guess.
  - 5) At 00:49:20 (0m, 30s), Peters states what Carroll is talking about ties into what was covered in Peters previous night's show.
  - 6) At 01:06:50 (1m, 40s), Peters says, "I ask myself every day, am I being a useful idiot...". the answer is, yes.
  - 7) At 01:16:11 (7m, 41s), Peters goes off on a few tangents:
    - ▶ Peters says that while he is not a trained journalist, he nevertheless "produces the same content, the same level of content as a trained journalist".
    - ► This should give you a good laugh.
    - Peters is indeed like most trained journalists today who protect their paychecks and not the integrity of their work.

- ► Peters responds to a comment from someone with a name that sounds like "*Malacca*"
- ► Peters states he will not build his shows to please one person and that he will "*piss people off every single night...*".
- ► This is more lame self sensationalizing.
- Peters video is 119 minutes long (i.e. 01:59:10 hours).
  - The Dorey/Carroll interview is about 82 minutes long (i.e. 01:21:32 hours)
  - O So what does Peters do in these extra 37 minutes?
  - O He indulges in self promotion, complaining about his low ratings and saying if he can't make a living out of *What's Up Canada* then he will have to consider doing something else.
  - As in all Peters videos I watched, there is the ever present message scrolling at the bottom of the screen that constantly begs us to financially support him.
- I don't see any value in the Dorey/Carroll interview other than it is filler that kills enough time to provide the pretense of a show and then allows Peters to get to his real purpose; to talk about himself and his financial woes.
- And this realization is what turned the light on and first cued me into what really drives Peters.
- I re-watched this video and noted an early part of the Dorey/Carroll interview is about how Carroll quickly went viral as a social media influencer. <sup>58</sup>
- Peters interjects and, what was a red flag for me, says he went from reaching up to 10 million people a month down to a relative few. <sup>59</sup>
- Peters blamed this hit on an internet lock down by the deep state.
- Peters commented, and this was a key comment for me:

"If you're averaging a million plus views a month on YouTube you're probably making anywhere between six to ten thousand dollars. **What do you think that does to a guy like me that's been cancelled?**" <sup>61</sup>

• Peters offers no evidence to support his claim he had millions of views every month and that he lost them because he was supposedly cancelled.

- Peters is saying, that no one is interested in watching him means no one is interested in saving Canada.




Figure 3: Peters thinking of closing his platform

- The point is Peters is not focused at all on Blackrock or winning this global war.
- Peters is only focused on himself and his financial woes.
- And BINGO, there we have.
- For Peters, "What's Up Canada" is a business, a way to make money for himself, just as his two partners are also a business and a way for Peters to make money.

#### 13.6 Video review - The end of the new world order

- This video is 03:15:49 hours long and was posted on August 29 of this year.
- Let me explain why I watched this particular video.
  - We little people are fighting in global war which aims to usher in a new world order of One World Government under the tyranny of Technocracy and Transhumanism.
  - The only way we little people can win this global war is if we eliminate the cabal and it's global network.
  - O The only way we can eliminate the cabal is if we unite, across Canada and across the world.
  - O We are not united and we are not uniting.
  - O We pose no threat to the cabal.
  - O We've been overwhelmed on all fronts.
  - We are not winning this war. We are losing and losing it badly.
  - O If we don't unite then we have already lost this war.
  - O Peters business partner Bryce Wade appears to agree with me. To quote Wade:

"Like at the end of the day, people seem to forget that we're all human on the same planet and we're living in the same world under the same authoritarian nonsense by the same group of authoritarian old guards that have been in power for thousands of years, right? So either we figure this shit out together or the future is going to be really dark and dire." <sup>65</sup>

- → Wade acknowledges the Cabal has been around for a long time.
- → Wade also acknowledges if we don't unite and work together then we've lost this war.
- The title suggests Peters has evidence we are not only winning this global war but that we are seeing the end of the new world.
- As you might imagine, this caught my attention and I was most curious to see what evidence Peters offered to support such a claim.

#### 13.6.1 The evidence

- Let's take a look at the nonsense Peters peddles as evidence that we are winning this war.
- The video title is click bait and most of the video contents contradict the title's premise.

- Appendix G lists the different segments I identified in this video. It also lists the segments that support or contradict Peters narrative that we are winning this war and supposedly seeing the end of the new world order.
- Amusingly, there is only about one hour of this video that supports Peters narrative while the other two hours contradict Peters narrative. 66
- Yes, you heard that right. Two of the three hours in this video contradict Peters implied claim we are winning this war and seeing the end of the new world order.
- Peters claim is primarily based on 35 minutes of single source, extremely biased, pro-Trump analysis by Susan Kokinda <sup>67</sup> at Promethean Institute.
- Kokinda is hardly a credible and trustworthy source of information because of her biased and fawning support for Trump.
- But even if Kokinda offered an unbiased and balanced review then Peters would still need to find many other credible and compelling sources to support and convince us that his narrative is indeed true.
- And yet, for all of Peters vaunted research skills, Kokinda's endorsement of Trump is apparently all Peters can find to support his narrative. <sup>68</sup>
- To add to my merriment, Peters shreds his credibility by concluding:

"I guess at the end of the day, what I'm saying when all of this is we're winning, guys. It may not seem like it, may not sound like it, may not feel like it, but we're winning, riaht?" 69

- You know that expression, "If it looks like a duck, sounds like a duck and walks like a duck ... then it's a duck".
- Well, with regards to winning this war, if may not seem like it, may not sound like and may not feel like then it's because we aren't winning.
- And then, wonders of wonders, Peters shoots himself in both feet, contradicting his own narrative.
- He parrots a video clip of a Redacted Podcast with Ken Paxton, a previous attorney general of Texas. 70

O This podcast starts off with the host saying:

"Well, we've got some big legal news to get to today. First, the Trump administration just pulled off the gloves and they are officially, it seems, going after George Soros and his son, Alex Soros. It's about time. Trump said on social media today that Soros should be charged with RICO (Racketeer Influenced and Corrupt Organizations Act) because of their support of violent protests."

- But Paxton argues throughout the podcast that it is unlikely Soros will be held accountable because Soros has subverted the legal system not only in Texas but pretty much across all of America.
- O Midway through this segment, Peters interjects, in agreement with Paxton, saying about Soros:

"If he's had that much of an impact on America, can you imagine the impact behind the scenes he's had in Canada where everything that George Soros spends his money on, right?" <sup>71</sup>

- O Peters rambles a bit and then, completely ignoring what he and Paxton have said, Peters illogically states:
  - "...but collectively, the deep state, the shadow government, the cabal, the swamp of the world is getting their asses handed to them from every freaking direction". <sup>72</sup>
- O This is a skit right out of Saturday Night Live.
- Paxton has clearly said Soros is untouchable and Peters, completely out of touch with reality, concludes this is proof we are winning this war and seeing the end of the new world order.
- O Does Peters even think before he talks?
- O BTW, the Trump, RICO and Soros news story is now dead in the water.
- O But hey, that doesn't matter.
- O Peters was able to fill an entire time slot with what was obviously fake news.
- After all, this is showbiz and entertainment that no one takes seriously and is quickly lost and forgotten.

### 14 Not in the solution business

- Now the good thing about a chatty-cathy windbag like Peters who works hard and takes great pride in not being concise and to the point is he likes to talk about problem, problems and more problem but apparently avoids solutions to these problems like the plague.
- Peters is apparently not into the solutions.
- Near the end of the live stream "*Being hated for truth*" Peters reviews and responds to a few comments posted by viewers during his live show.
- In a mocking tone, Peters reads one comment:

"Well what are the solutions then?" 73

Peters response is:

"I'm not in the solution business guys. The solution business has to be everybody."

• About a minute later, Peters says:

"I was seeing a comment there that's kind of distracting me...about somebody that i don't really trust. That's another person trying to sell solutions that has got no business selling solutions. And I'm not arrogant enough to think that I can provide solutions. That's not my job. My job is to try to find some clarity, to try and find you know a path through the smoke and mirrors and deception. It's not to tell people what to do. It's to tell people what they need to know so that they can decide for themselves what they need to do, right!" <sup>74</sup>

- This is hilarious. What obscure logic is Peters using that concludes a person trying to find solutions is arrogant but it is not arrogant for him to try finding truth and clarity?
- Something I've noticed is that Peters likes to flatter and sensationalize himself...just a wee bit...occasionally...as in regularly.
- But there we have it folks, right from the horses mouth.
- Peters is not in the "solution business" and only "arrogant" people sell solutions.
- This is recent, from September 3, 2025.
- Now let's look at three instances in the videos I watched where Peters does propose a solution.

- Instance #1: In episode 46 of "Bankers, Bandits, Bullion and Buck with Bryce" Peters refers to the 2010 Iceland constitutional reform which put bankers in jail for engineering the countries financial crisis.
  - O Peters says, "If we were to pull an Iceland and do the same thing Iceland did in 2011 or America did in 1776, guess what? All of that debt goes poof. The debt goes with the criminals, the crime syndicate, the corporations." <sup>75</sup>
  - O Now I may be wrong, but that certainly sounds to me like Peters is proposing what he thinks is a viable solution for how we take back Canada from what he says is the "*crime syndicate*" <sup>76</sup> illegally operating as the Government of Canada.
- Instance #2: In "*The end of the New World Order*", Peters shows a video clip of Neil Oliver. <sup>77</sup>
  - O Neil talks about "The reality that Britain is bankrupt".
  - O After Neil's clip is finished, Peters states, "We need united mass non-compliance all around the world". <sup>78</sup>
  - O Again, our unity is a solution and that solution is proposed by Peters himself. <sup>79</sup>
- Instance #3: As I discussed in the section 6, Peters has two side businesses and, wouldn't you know it, he claims both of them as solutions in our fight in this global war.
- So it seems that Peters is actually in the solution business, providing of course, that he is the one proposing the solution.

# 15 Gremlins & sabotage!!!

- Peters shows are regularly sabotaged by gremlins, hackers and CSIS (i.e. the Canadian Security Intelligence Service), at least that is what Peters wants us to believe.
- From part 3 of the video "Do not watch this you will end up on a government watch list":
  - $\circ$  "My stuff is starting. The gremlins are back." <sup>80</sup>
  - "I just saw your comments the audio is off. I did get a blasting notification that the gremlins are back." "81"
  - "You're gonna bear with me ... when I get the gremlins out ... the gremlins never get tired of trying ... apparently they haven't figured out how determined I am to keep doing what I'm doing. But they're trying man, trying real hard" 82
- While this makes for good showbiz and entertainment, Peters has technical problems that he
  doesn't know how to resolve.
- Let me explain.
- Peters live show places a heavy demand on his computer's hardware and software resources.
- As a high level understanding, there are 3 resource intensive processes occurring simultaneously in Peters shows.
  - Process #1: Peters records from a microphone and a camera.
  - Process #2: In the majority of Peters live shows, he plays video clips made by other people. This requires his computer to download (i.e. receive input) and playback (i.e. output) video clips in real time.
  - Process #3: Peters simultaneously live streams (i.e. outputs) to his four social media channels Facebook, Rumble, Wimkin and X/Twitter.
- All three processes place very heavy demands on RAM (random access memory), CPU (central processing unit), GPU (graphic processing unit) and network resources.
- These processes use multiple hardware devices, software drivers, software applications and remote platforms.
- For a home grown system, this is a very sophisticated configuration for which problems or errors are expected to occur.

- Here is an example showing lags in one of Peters shows that was caused by technical problems.
  - O Note, Peters does not claim the lags were cause by Gremlins & Co. The point is to illustrate the problems are technical in nature and are not caused by sabotage.
  - O In the part 1 of Peters video "<u>Saying the quiet parts out loud</u>", there are short duration lags at time 02:48:53, 02:48:57 and 02:49:53. These lags occur while Peters is playing a video clip from Tal Oran's YouTube channel.
  - O But these lags do not occur if you watch the video directly from <u>Tal Oran's YouTube</u> <u>channel.</u> 83
  - O This means the lags in these three examples were technical in nature and not caused by Gremlins & Co..
- For Peters to attribute his live stream problems to Gremlins & Co. is:
  - 1. a dodgy way of trying to improve his lacklustre internet presence and
  - 2. where truth and clarity take second place to self-sensationalizing and trying to boost ratings.

# 16 Cringe content

- Let's move onto the next part of this report which is titled "cringe content".
- In Peters videos I watched, there is an overall lack of organization with an excess and glut of repetitive material whose sole purpose is to turn a 30 minute show into a three hour show.
- In this excess and glut of material, there is content of such low quality, flagrantly biased and/or obvious propaganda content that they mock Peters boast he is all about the truth and clarity. They're so bad that I refer to them as cringe content.
- Let's take a look at a number of examples.

### 16.1 Cringe Content #1: Captured Hamas prisoners of war

- Here is a little context to this first bit of cringe content.
- Before showing it, Peters has just parroted about 20 minutes of blatant, 100% pro-Israel propaganda from TVN Israel, the propaganda being so blatant that even Peters himself acknowledges is it "obviously from a biased lens". 85
- Seemingly oblivious to the definition of the word "*irony*", Peters accuses the mainstream media narrative of being dangerous propaganda.
- Peters makes more of a fool of himself by showing about another hour of one-sided, biased, pro-Israel content, which includes the cringe content in this section.
- The cringe content in this section is that Peters parrots a video clip from <u>SaharTV</u> where Palestinian supposedly captured in the October 7<sup>th</sup> attack on Israel give recorded confessions. <sup>86</sup>
- Peters tosses journalistic integrity out the door, telling us he has not had a chance to watch it, the point being he is blindly showing us unauthenticated and unverified footage.
- If the people we see were actually captured during the October 7<sup>th</sup> attack on Israel then they are prisoners of war, they are not terrorists. <sup>87</sup>
- Recorded confessions from prisoners of war are notoriously unreliable. Such confessions should be assumed, and will routinely be, obtained under torture and other coercive means, something Peters appears to acknowledge. <sup>88</sup>
- It is inconceivable that Peters is unaware of Israel's horrific treatment of Palestinian prisoners.
- As for Sahar, he discredits himself by regurgitating the tired and worn lie that Israel does no wrong and Palestinians are always wrong.
- In turn, Peters discredits himself by being a trained seal that claps on cue.
- It is a weak and lame argument for Peters to conflate what he says Muslims are doing here in Canada with Palestinians fighting for their freedom, country and survival, you know, the same thing Israelis claim to be fighting for. What's happening here in Canada and what's happening in Gaza are two completely different things.
- There are only two messages we should take away from Sahar's video clip:

### 16.2 Cringe Content #2: Fake audition

- Let's take a look at a 2<sup>nd</sup> example of cringe content, something that shows us how biased and gullible Peters is.
- This is the nonsense Peters peddles as his deep dive, with truth and clarity, into our migrant crisis.
- Peters shows a short video clip made by a Jewish comedian.
- The video clip is only about 6 minutes long and appears in Peters 15 hour video titled "*Do not watch this you will end up on a government watch list*".
- I've watched this short video clip quite a few times and laughed each time.
- I had a lot fun with it, which is why this section is relatively long.
- Again, Peters should be cringing in embarrassment.
- Let's get into the details.

### 16.2.1 Lyle Culpepper

• Lyle Culpepper <sup>90</sup> is a Jewish comedian shown in the next figure. <sup>91</sup>

- Culpepper made a video of fake auditions he held for a pro-Hamas rally.
- The intent was to ridicule and mock people who support Hamas.
- A second person, Tal Oran, shows Culpepper's video on his <u>YouTube channel</u>.
  - O The title of Oran's video is "Zionist Holds 'Audition' for Pro-Hamas Rally (Exposes Them With Hidden Camera)"
  - O The camera is not hidden and the people being auditioned are fully aware they are recorded.

- Oran parrots (i.e. copies) Culpepper's video and, in turn, Peters parrots Oran's video.
- What I immediately noticed is Culpepper's video is heavily edited. 93
- The rapid panning back and forth between different people and short audio clips is a dead giveaway that Culpepper is up to something.
- As it turns out, Culpepper has no ammunition and the only way he can come up with something was with extensive and deceitful video editing as well as faked footage.

- I'll walk you through a number of obvious examples which illustrate why this is a cringe video clip.
- I am surprised at how easily Peters is duped.

### 16.2.2 How many hours of recordings to produce a 6 minute video?

- Culpepper's video clip shown by Oran is only about 00:05.30 minutes long.
- For me, a good part of the entertainment came in recognizing the amount of effort Culpepper invested for so little return in his lame attempt at satire.
- The first question is, what was the total duration of all auditions? This will give us an idea of how much time Culpepper had to spend to produce his short video?
- Let's make a conservative estimate.
- The next figure shows the auditions were recorded during the day and during the evening. Note the top two images show daylight in the background window while the bottom two images show darkness in the background window. This indicates the auditions were held over a good part of a day.

- For the auditions to appear real, we can conservatively assume Culpepper had to give each person at least 15 minutes.
- It likely many more than 12 people were auditioned. 95

So Culpepper would have had to continue auditioning people as he fished for the reaction he wants. Evidence supporting this assumption comes from persons #7, #10 and #12 in Table 4. Persons #7 and #10 are shown speaking for only one second while person #12 was not shown speaking at all. This means, for these three people, the rest of their audition did not give Culpepper the reaction he was fishing for.

- Based on these numbers, the total time for all auditions is 180 minutes (12 people x 15 minutes/person) or 3 hours.
- So a very conservatives estimate is that there are at least 3 hours of recorded conversation, body language and context.
- And in 3 hours of recordings, Culpepper is only able cherry pick under 6 minutes of recording, which as I will show, feature heavy video editing and likely faked footage.

### 16.2.3 Two requirements to seal the joke

- For Culpepper's fake audition to be funny and successful in showing Hamas supporters are foolish and ridiculous necessarily requires two things:
  - 1. We must hear the complete and unedited recording of the conversation between Culpepper and the person he auditions.
  - 2. We must simultaneously see both Culpepper and the person he auditions so we can be reasonably certain the recording has not been edited or faked.
- To illustrate these two requirements, I did a quick search on the internet and found this video by Justin Awad "CAN'T BELIEVE IT: Gen Z Americans can't answer these basic questions".
- Justin and the people he asks questions to are always visible and we hearing everything they say.
- For example, at time 00:00, Justin asks a woman "What country is the Queen of England from?". For the entire time, we see and hear both Justin and the woman.
- What is seemingly funny is that we can confirm for ourselves the recording is unedited and that the woman appears clueless to the fact that the question includes the answer. <sup>96</sup>
- Conspicuously, Culpepper ignores and flouts both of these requirements.

### **16.2.4** Ignoring George Soros

- The video starts off with a screen shot of the New York Post stating "George Soros is paying student radicals who are fueling nationwide explosion of Israel-hating protests". <sup>97</sup>
- Do you see the unintended entertainment?
- Soros is a Jew.
- The laugh is that Culpepper the Jew, completely ignores Soros the Jew, who is the villainous inspiration behind the entire audition.
- Culpepper only targets the pawns of our Jewish villain but not our Jewish villain himself.
- This hypocrisy goes right over Peters head and the joke is on Peters for clapping like a trained seal.
- Now let's look at several example of obvious problems in Culpeppers video.


### **16.2.5** Example 1

- The laugh in this clip is that Culpepper uses video editing to fake a conversation that never happened.
- Keep in mind the two requirements (see section 16.2.3) are not met.
- At time 00:51:53, Culpepper says, "We are an anti-Zionist organization".


• The next figure shows the screen capture at this time. The transcript appears at the bottom of the image.



- Note the following:
  - 1. We see both the woman and Culpepper.
  - 2. Note the angle of the woman's head and body. Her body is facing the camera while her head is angled away from the camera.
  - 3. The woman's arms and hands are at the side of her body and we clearly see her left arm and hand.
  - 4. The woman is centered in her half of the frame.
  - 5. We are not given the full conversation Culpepper has with this woman.
- At time 00:51:54, apparently only one second later, the woman says "*That doesn't bother me*".

• The next figure shows the screen capture at this time. The transcript appears at the bottom of the image.



- Note the following:
  - 1. We see the woman but not Culpepper.
  - 2. The angle of the woman's head and body has completely changed. The woman's body is no longer directly facing the cameras but is noticeably angled away from the camera.
  - 3. The woman's arms and hands have noticeably moved to the back of her body. We barely see her left arm and hand.
  - 4. The woman is slightly off-center in this image.
- We are looking at what Culpepper wants us to believe is only two seconds of video, from time 00:51:53 to 00:51:54.

- I laughed at Culpepper because this is not comedy. It's dodgy video editing.

### **16.2.6** Example 2

- The obvious video editing in this next example is what caught my attention and made me take a closer look at it.
- Culpepper appears to fabricates an exchange that never happened.
- This segment is most likely faked.
- Again, the two requirements (see section 16.2.3) are not met.
- Culpepper takes a series of short one to two second video clips from different auditions, splices
  them together and appears to remove the original audio, dubbing over with a recording of his
  own voice.
- We hear the following over 15 seconds, from time 00:55:47 to 00:56:02

"One of the things we're looking for in our leaders is what is called escalation. Sometimes our protests escalate the violence. We have some lawyers on our staff who'll pay a little extra if you get arrested. They'll bail you out escalating the violence...Do you think that's something that you'd be comfortable with?

• Again the two requirements (see section 16.2.3) are not met.

• On the one hand, the VISUAL makes it clear we are watching a series of short clips from different auditions.

- On the other hand, the audio in the first 10 seconds (i.e. video clips #1 to #10) presents the
  illusion we are listening to the raw, unedited recording of Culpepper's voice across all these
  auditions.
- It is very unlikely Culpepper could seamlessly synchronize raw recordings of his voice across multiple auditions. Instead, it more likely that the only reason we hear an uninterrupted statement by Culpepper is because he removed the original audio from each of the short video clips and dubbed over them with a recording of his own voice. <sup>98</sup> But that's cheating.
- In the next/following four seconds (i.e. video clips 11 to 14), we hear three people apparently affirming that, yes, they would escalate to violence. However...
- It beggars belief that anyone would agree, in an obviously recorded and relatively short audition with a complete stranger like Culpepper, to acts of violence.
- Culpepper obviously did not get the other 8 people to agree to violence. Nor did he get these three people to agree to acts of violence.
- What we hear from these three people is something they said in another part of their audition that has nothing to do with escalating to violence and which Culpepper quotes out of context.
- In other words, the supposed exchange we think are hearing in this 15 second segment is most likely faked.

### 16.2.7 Example 3

- The laugh in this next clip is again we are watching faked footage. It illustrates the same problem shown in Example 2.
- Again, the two requirements (see section 16.2.3) are not met.
- At time 00:51:56, Culpepper says, "*We skew a bit anti-jewish as well*", supposedly part of Culpepper's introducing himself and what he does.






Figure 8: Screen capture at time 00:51:56

  - 1. Look at Culpepper's left arm. His left elbow is not resting on the table top. His left thumb and fingers are fully extended outward and pointing to the left.
  - 2. His right elbow is resting the table top and the fingers on his right hand are slightly extended out.
- At time 00:51:57, apparently only one second later, the woman says "*I think it should be fine*"
- The next two figures shows the screen captures 00:51:57 and 00:51:58, only 1 second and 2 seconds later. The transcript appears at the bottom of each image.

- Note the following:
  - 1. The zoom factor for both the woman and Culpepper has noticeably increased between Figure 8 and Figure 9.
  - 2. Look at his left arm. Culpepper's left elbow is resting on the table top (at both time 00:51:57 and 00:51:58), as he brings his left hand to his chin. His left fingers are completely curled inward and his left hand mid-knuckles are completely pointing to the right.
  - 3. The fingers on his right hand are curled inwards.
  - 4. The woman's response is tentative and conditional. The woman does not appear to be responding to "*We skew a bit anti-jewish*" but rather something completely different that Culpepper has said.
- We are looking at what Culpepper wants us to believe is only three seconds of video, from time 00:51:56 to 00:51:58.

• At time 00:56:30, we hear a short exchange between this same woman and Culpepper:

woman - "I'm okay with violence so long as it's not on the protesters."

Culpepper – "On the protesters?"

woman – "Yes, does that help?"

Culpepper - "Oh, so I'm saying so...then who...against, you saying against like police? What do you, I don't understand."

woman – "Yes, I'm not going to incriminate myself".

- Again, what we see and hear is highly selective video editing.
- When I heard this, I definitely wanted to know the full exchange between them.
- Context is everything and Culpepper's cheap laugh depends upon our not knowing the context and details of the conversation.
- It is reasonable to say Culpepper has baited this woman into talking about violence and manipulated their exchange with the intention of making this woman look bad.
- The woman recognizes Culpepper has baited her and she makes very clear she is not taking the bait.
- This is how low Culpepper stoops to get a cheap laugh.

### **16.2.9** Example 5

• Culpepper says, at time 00:51:31:

"We're fighting for the collapse of western civilization and also we're trying to bring sharia law to America...It's working in Europe right now. There are places in Europe that have sharia law".

- The problem for Culpepper is none of the 12 people took the bait and did not give Culpepper the reaction he was fishing for.
- This is but one of a number of instances where Culpepper is fishing but clearly comes up empty handed.
- The joke is on Culpepper.

#### 16.2.10 Example 6

- I laugh when Zionists are compared to Nazis <sup>99</sup>.
- At time 00:53:38 a man sitting down says, "They are Nazis".
- At time 00:53:41, a woman says "The Zionists are acting like Nazis".
- Both people appear speaking for only one second, which demonstrates highly selective video editing.
- Assuming each audition is at least 15 minutes long, for a total time of 30 minutes between the two of them, the best Culpepper can get from these two people is one second. These two people did not give Culpepper the reaction he needs.
- Better still, there is nothing provocative about comparing Zionists to Nazis. What Israel is doing is one-sided slaughter and is the very definition of ethnic cleansing. Moreover, most people in the world also agree this is an act of genocide against the Palestinian people.
- In other words, most people will say, "I don't get it. That's not a joke. It's a fact".
- And that is what I found is funny, Culpepper is the joke because this is such lame satire.

But that's okay, it doesn't fit with our narrative So we don't have to address it that way. It's all about curbing it, so it doesn't seem like the fault of, you know. So if you were to be armed with that kind of information would you still be willing to go out there and say things that are not necessarily true?".
- The next figure shows the screen capture at this time. The transcript appears at the bottom of the image.




Figure 12: Screen capture at time 00:55:26

- It is clear this guy senses Culpepper is baiting him and he doesn't take the bait.
- The laugh is that, using some unfathomable logic, Culpepper somehow thinks this makes him look good and this guy look bad.
- Now, most people who are wearing their thinking cap and using common sense will say the black guy wins, Culpepper loses, game over.
- Moreover, this is the best Culpepper could cherry pick from this guy's audition as well as hours of recordings from all the other auditions.
- And the icing on the cake is Peters thinks Culpepper's failed satire is funny.

#### **16.2.12** Example 8

- The laugh in this clip requires viewers to have done their own homework and understand the official narrative is a lie.
- Here is a short exchange between Culpepper and a Muslim man: 100
  - Culpepper "You're in support of Hamas, right? You support Hamas."
  - O Muslim "In my religion, which is the same religion Hamas goes about, Islam, there is no killing, no innocent killing is ever tolerable". <sup>101</sup>
  - O Culpepper "Right, you don't see it happen. you don't see that happening from Islam. Name one incident you know. You can't." 102
- Culpepper then shows four pictures about different terrorist attacks, implying all four attacks were perpetrated by Muslims:
  - 1. A picture of 9/11 trade tower in flames. 103
  - 2. A picture of a New York Times article titled "Paris terrorist attack kills over 100. France declares state of emergency". <sup>104</sup>
  - 3. A picture of a New York Post about "At least 22 dead as UK terror blast hits Ariana Grande gig. Killing our kids. <sup>105</sup>
  - 4. A picture of a Guardian article "How the Hamas attack on the Supernova festival in Israel unfolded" <sup>106</sup>
- Culpepper parrots the official narrative which is always 100% disinformation, misinformation and propaganda.
- It is highly improbable any of these four terrorists attacks were committed by Muslims.

- O "Architects & Engineers for 9/11 Truth" 107

  - 3. time 00:56:11, Culpepper appears to say "Ya ever spit on couple Zionist babies?"
  - 4. time 00:56:14, Culpepper continues *I mean, yeah, you know, they're not going to remember.*"
  - 5. time 00:56:16, the Woman grins and says "Yeah right, right, right"
  - 6. time 00:56:18, Culpepper "It's just so refreshing that you don't have principles".
- There are four laughs in this short video clip.
  - 1. The 1<sup>st</sup> laugh is the Culpepper appears to be speaking from experience:
    - a) "Video showing fresh Haredi spitting attack on Christians draws wide condemnation"
    - b) "Jews spit on Christians in Israel"
    - c) "<u>Outrage after video shows ultra-Orthodox Jews spitting on ground beside Christian</u> procession"
  - 2. The 2<sup>nd</sup> laugh is that man shown at time 00:56:10 is not talking and doesn't respond. Culpepper's joke is a flop with him. Indeed, Culpepper was unable to get any of the 12 people appearing in this video to agree that they would spit on a Zionist baby.
  - 3. The 3<sup>rd</sup> laugh begins at time 00:56:11 in Peters video or time 04:32 in <u>Tal Oran's video</u>.
    - → It's best to watch and listen to Tal Oran's video where the audio is a bit clearer and the audio is properly synchronized with the lip movement (which is not the case in Peters video).
    - → In the audio, Culpepper actually asks a question, using the past tense, "*Ya ever spit on couple Zionist babies?*".

## 16.3 Cringe Content #3: Israel is not starving Palestinians

- The 15 hour video "*Do not watch this you will end up on a government watch list*" has a few segments that claim Israel is not starving Palestinians. <sup>114</sup>
- They serve up a blatant, biased, one sided, pro-Israel narrative where Israel is never wrong and Hamas is always wrong.
- They absolve Israel of all sins and imply Israel has no motive, none whatsoever, for using starvation as a weapon of war against the Palestinians.
- Before I continue, here is a quick exercise for you to perform.
  - O Do a quick internet search using the phrase, "Israel uses food as a weapon of war".
  - O I learned that Israel uses food as a weapon against Palestinians many years ago when I was much younger.
  - Israel can do this because it controls all borders and everything that gets into Palestine, that is, aside from what is smuggled in.
  - O Now why it is that Peters is seemingly oblivious to what the world has known for at least half a century and, in particular, has been considered an acceptable tactic by all armies for several thousand years (e.g. sieges and military blockages)?
  - As has become a theme in this report, Peters throws truth and clarity out the window.
- Let's look at what Peters offers as supporting evidence that Israel is not starving the Palestinians.
- Time for some more laughs?

#### 16.3.1 Tal Oran & X/Twitter

- Peters parrots another <u>Tal Oran</u> video where a journalist asks questions to supporters at a pro-Israel rally. <sup>115</sup>
- Oran opines the journalist is pro-Palestinian, she is confrontational and this backfires spectacularly.
  - Except there is no confrontation, no backfire and everything is civil.
  - Oran embellishes because, well, that's what showbiz and entertainment are all about.
- Let's look at 3 short segments in this video clip.

Segment 1: The journalists asks a black man several questions, one of which is:

"We've seen Netanyahu has said that he denies that there's starvation going on in Gaza. But the UN and other international organizations have said otherwise. What do you think about that?" <sup>116</sup>

- O The black man responds with "the UN is a terrorist organization". 117
- O This can be interpreted as:
  - I. the Palestinians are not being starved, or
  - II. a deflection that avoids answering the question.
- O Regardless of the interpretation, all the black man offers is his opinion.
- There's nothing wrong with expressing an opinion, but it's not hard evidence.
- The laugh is on Peters for thinking an opinion is compelling evidence that Israel is not starving Palestinians.

# Segment 2: Halfway through this video clip, Peters interjects and shows a post from X/Twitter:

"Israel's not blocking food from entering Gaza. There's enough food at this aid base to feed every person in Gaza for at least a week, but the UN, Hamas etc. refused to distribute the food efficiently. Instead it sits here to spoil and be stolen. How is that Israel's fault?" <sup>118</sup>

- O We see picture of a guy wearing a helmet and a vest. In the background, wood skids are loaded with what we are suppose to believe is food, all sitting in the sun.
- O Peters then states:

"The UN and Hamas want this....This is where we end up with this crap on the streets, hired protests and this insurrection that is literally colonizing our country."

- O This is so laughable nonsense.
- The photo looks like it is staged.
  - → It has a narrow angle view.
  - → We cannot identify the location.
  - → There are no other people or vehicles.

- → There are no identifiable markings on any of the bags, at least that we can make out.
- → This looks like a classic wartime propaganda prop.
- → Peters swallows it line, hook and sinker.
- Peters opines "the UN and Hamas want this", where "this" refers to the starvation of Palestinians being blamed on Israel.
- O The laugh again is on Peters for thinking what appears to be staged photo, plus his opinion, is compelling evidence that Israel is not starving Palestinians.
- Segment 3: The journalist asks a tall white man several questions <sup>119</sup>, one being about the withholding of supplies to the people of Gaza. This man offer his opinion but again, nothing even remotely related to hard evidence.
- To summarize, the only evidence Peters offers that Israel is not starving Palestinians is entirely opinion based and from very obvious pro-Israeli supporters.
- It's not credible.
- What makes this all the more laughable is that this is the best Peters could find.
- There is no truth or clarity in any of this.

- Peters parrots a video clip of an Eylon Levy interview by TBN Israel. 120
- In this interview <sup>121</sup>, the pro-Israel propaganda bullshit is laid on so heavily that even Peters felt the need to say about it, "*Obviously from a biased lens*" <sup>122</sup>. Incidentally, in the next breath Peters amusingly contradicts himself by saying that doesn't make any of what Levy says is incorrect. Go figure!
- TBN Israel and Levy are peddling blatant propaganda and I'll leave it at that.
- But let's take a look at the entertainment Peters provides. He interjects with:

"I just want to clarify here, I just want the killing to stop. Sharing a voice out of Israel is not an automatic support for what Israel is doing or Bibi (i.e. Benjamin Netanyahu). I got no use for that quy. He is pure evil as well.

The fact of the matter is there are literally millions of Israelis in Israel trying to stop this shit

and get rid of BB to. So unfortunately, none of our mainstream news is giving anybody any of this. And like I said before, mislead destroyed is the result. "So I'm here to ask you a simple question. I know that we portray Islam and all Muslims as bad. But there's 1.8 billion Muslim followers of Islam. We have 8 million plus Muslim

Americans in this country and I don't see them represented here. But my question is how can we fight an ideological war with weapons? How can we ever end this war? ... How can you ever win this thing if you don't address it ideologically?" <sup>127</sup>

- Brigitte Gabriel, a member of the council, responds. <sup>128</sup>
  - Gabriel argues that while the large majority of people in all conflicts are peaceful, it is the minority of radicals that take control and are the real problem.
  - So any argument or question prefaced on the a majority of people being peaceful is a meaningless distraction/deception because it is the controlling minority that kills tens of millions of people.
- While Gabriel is directing her point at radical Muslims, her point applies to radical minorities in all countries, including Canada and USA. <sup>129</sup>

- Now let's move onto part 2 of "Saying the quiet parts out loud".
- Peters starts part 2 with:

"Warning tonight guys. One of the clips that I'm going to be playing is going to be a level of graphic that I never thought I would be forced to play, to share to the world about how sad Canada has become. But it's incredibly graphic, good thing it's only a few seconds long." <sup>139</sup>

- This immediately tweaked my curiosity and had me asking, what else was there about our migrant crisis in Canada that is so graphic that Peters didn't show it in part 1 or in the four parts of "Do not watch this you will end up on a government watch list" but now he feels strongly compelled to show us in part 2?
- What I was expecting is something so new that few people know about it. And to be honest, what I was expecting was something a little juicy, along the lines of:
  - 1. Honor killings in Indian families in Canada because daughters refused prearranged marriages, or
  - 2. An Indian who uses his 20th generation heirloom sword for ritual decapitation of Canadian white Christian babies, or
  - 3. An Indian that tries to have sex with a grizzly bear.
- Whatever it is, it is the headline story for part 2 and I am expecting Peters to lead with his headline story. Except he doesn't.
- Peters covers 5 different issues before finally coming to the headline story.
- And when that moment arrives, about 30 minutes into part 2, Peters cautions us with:

"This portrays an East Indian immigrant in Canada being asked to leave a Starbucks and you'll see for yourself what he's doing. But the point, the only reason I'm sharing this with you guys is because I know you guys are going to be pissed. And we need to see that nothing is being done with all of these guys. But the point of that is, it's going to come up here in the next clip? Yep, the next clip. Canadians are right to be pissed off. They should be pissed off. I'm pissed off that not more Canadians are pissed off. We are not nearly pissed off appropriately. And until we are, nothing is going to change. We're

- Starbucks??? Why that's a coffee shop!
- Naturally I am somewhat disappointed because I really was hoping to see an Indian trying to have sex with a grizzly bear.
- Anyways, the video clips starts playing <sup>141</sup> and I see a guy sitting.
  - O I'm trying to read, but can't make out, what the onscreen text says.
  - O Before I can blink twice, the video is finished playing and I don't know what I've just watched.
  - O I have to watch it a second time, pausing the video, before I realize the guy is shitting on the floor in Starbuck's while sitting on a chair.
- Huh...that's it Peters?
  - O This is what has gotten your panties in knots?
  - O This is your deep dive into our migrant crisis?
  - O This is your truth and clarity?

- I've watched a few videos of Indians shitting on our beaches.
  - O I've watched a few videos of Indians shitting on our streets.
  - O I've watched a few videos of Indians shitting on their beaches and streets in India.

The narrative Peters tries to spin in this video is we are winning this global war against the Cabal and the end of the Cabal's new world order is at hand. In my notes, I identify whether the segment supports, contradicts or is neutral about Peters narrative.

Segment 1 and 2 are neutral because they are unrelated to Peters narrative.

My criteria for classifying a segment as contradicting Peters narrative assumes the end of the new world order means the issue or topic Peters addresses should NOT be happening. For example, segment 3 is about Muslim youths in France that want to restrict women's rights. This reflects our migrant crisis in all western countries, which continues to escalate and for which we currently have no solutions. This means Cabal's agenda for a new world order of One World Government is successfully moving forward and that the push for a new world order is alive and well. Segment 4 about Lola in Scotland is another example that contradicts Peters narrative.
